# STATEMENT — FRESNO COUNTY BOARD OF SUPERVISORS

Good morning Chairman Buddy Mendes, Members of the Board, My name is **Rocky Ray Bucci**, and I live at **2324 S. Lewis Lane, Sanger, California**. I am here today asking you to grant my **Application for Leave to Present a Late Claim** concerning an incident that took place on **July 26, 2023** at my property. On that day, Fresno County Sheriff's deputies executed a SWAT operation at my home, seized my security video recorder and two legally owned rifles, and removed evidence I had offered to help law enforcement. Despite my cooperation and my attempts to report suspected criminal activity to local police prior to the incident, my property was taken and **never returned**. I want the Board to know that I acted in good faith. After the incident I contacted the **Fresno County District Attorney's Office**, the **Sheriff's Records Division**, and the **Sanger Police Department** to understand what had happened and how to retrieve my property. No criminal charges were filed against me; I was told the case remains under investigation, but there is no resolution and no explanation. At no point did anyone inform me of the **six-month deadline** for filing a government tort claim. I learned about that requirement only after contacting County Risk Management well beyond the six months. I have acted as soon as I became aware of the correct procedure. I'm not asking you to decide the merits of the case today — only to allow me to file the claim so it can be reviewed fairly and I can seek return of my property and compensation for the losses I've documented. With respect, I ask this Board to grant my late claim so I can finally have this matter addressed on its facts. Thank you for your time and consideration. Respectfully,
