10 WHEREAS, on November 18, 2025, the Fresno County Administrative Office created the Office
11 of Housing and Homelessness Division to centralize the department of Housing and Urban
12 Development, Department of Social Services, and County Administrative Office homelessness
13 response roles and programs. This action required the creation of an expenditures Org (5428) and
14 consists of the transfer of operational control of the identified homelessness programs and associated
15 positions permanently from the Department of Social Services to the Office of Housing and
16 Homelessness Org 5428; and

17 WHEREAS, the County Administrative Office Org 0120 will transfer one Program Manager
18 position to the Housing and Homelessness Org 5428, which will require the associated appropriations
19 for salaries and benefits in the amount of \$76,546, and estimated revenues in the amount of \$44,417 to
20 be transferred from Org 0120 to Org 5428; and

21 WHEREAS, said monies are included in the County Administrative Office Org 0120 FY 2025-26
22 adopted appropriations and estimated revenues and must be reduced by that amount to account for the
23 transfer of the position to the Housing and Homelessness Org 5428; and

24 WHEREAS, Section 29130 of the Government Code provides for the appropriation of these
25 funds by a four-fifths vote of the Board of Supervisors.

26 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is
27 authorized to decrease the appropriations and estimated revenues in the FY 2025-26 County
28 Administrative Office Org 0120 as follows:

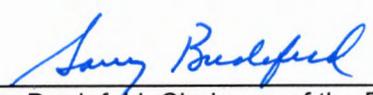

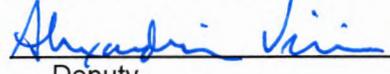
