I want to thank you for your unrelenting efforts to eliminate the Mello-Roos taxation arrangement in several Shaver Lake neighborhoods, no matter the outcome.

I have lived in the Wildflower neighborhood for many years and I do not recall our neighborhood ever needing or requesting additional Sheriff department support over and above what is the "normal" department services. In fairness, I assumed a Mello-Roos tax was supposed to positively enhance or increase routine Sheriff services in our neighborhood and would not necessarily only "kick in" under extraordinary events. To my knowledge, this has not happened. But, I could stand corrected on this issue simply because the Mello-Roos intent and execution seems somewhat unclear to me.

Therefore, I join others up in the Shaver area in wishing to dissolve this Mello-Roos tax and I would think the cost to eliminate Mello-Roos should be far less than the \$10,000 suggested at the last Board of Supervisors meeting.
