WHEREAS, the County of Fresno has received an unanticipated \$1,839,039 from the State of California for a half cent sales tax for public safety allocation; and

WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 Sheriff-Coroner-Public Administrator Organization 31113202 as follows:


