RESOLUTION

WHEREAS, California Planning and Housing Element law requires every local government to prepare and adopt a general plan and housing element; and

WHEREAS, Housing Element law requires every jurisdiction to adequately plan to meet the housing needs of everyone in the community. California's local governments meet this requirement by adopting housing plans as part of their "general plan" (also required by the state). General plans serve as the local government's "blueprint" for how the city and/or county will grow and develop and include seven elements: land use, transportation, conservation, noise, open space, safety, and housing. The law mandating that housing be included as an element of each jurisdiction's general plan is known as "housing-element law"; and

WHEREAS, the Department of Public Works and Planning is responsible for General Plan and Housing Element implementation policies and programs and it has become apparent that additional resources are needed to carry out these responsibilities; and

WHEREAS, \$58,000 is available in the Committed Fund Balance for Post Budget Mitigation Fund 0001, to fund the additional cost; and

WHEREAS, said monies were not included in the FY 2019-20 adopted appropriations for the Public Works and Planning – Water & Natural Resources Org 43600300; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Public Works and Planning – Water & Natural Resources Org 43600300 as follows:
