The Board of Supervisors of the County of Fresno has set January 10, 2017 at 9:00 AM at the Fresno County Hall of Records, Board of Supervisors Chambers, 3rd Floor, 2281 Tulare Street, Fresno, California to consider adoption of the ordinance summarized below. SUMMARY OF PROPOSED ORDINANCE Section 2.62.037, "Electronic Filing of Campaign Disclosure Statements", to Fresno County's Ordinance Code, Title 2, Chapter 2.62. Proposed Section 2.62.037 requires elected officers, candidates, committees and controlled committees and all other persons or committees mandated by State law to file campaign statements with the County, and have received contributions or made expenditures of \$5,000 or more, to electronically file campaign statements using the Registrar of Voter's online filing system. Required filers shall not be charged a fee to file campaign finance disclosure statements online and will not be required to file a paper copy of that statement with the Registrar of Voters. Second Hearing of proposed Section 2.62.037 will be January 31, 2017. Section 2.62.037 would take effect March 2, 2017.
