#### APPLICATION QUESTIONS

# 1. In the event that an applicant is up to date on rent but behind on other expenses such as utilities, can the Housing Retention Administrators pay the utility companies directly?

CARES money can be used to pay non-city utilities such as PG&E, Comcast, and AT&T directly. However, CARES guidelines strictly prohibit funds to be used for City utilities, such as water, sewer, or solid waste.

### 2. What about payday or personal loans people have taken out to pay rent/mortgage, how do we collect proof if they are not behind on rent?

It can be listed under the question "If you are not behind rent ..." and provide proof.

#### 3. Bills incurred or due?

We are providing the funds to you and your organization needs to distribute the funds how you see fit.

### 4. If the applicant only owes \$400 in back rent, plus \$200 in PG&E, may we only pay those bills for them and apply the rest of their award to future rent?

The applicant must provide evidence that the grant will be used to prevent eviction or support housing related financial assistance. In order to receive more than the

\$400 in back rent and \$200 in PG&E assistance, the applicant would need to provide evidence that additional money is needed to pay future rent.

# 5. Our controller is requesting we receive a W-9 from landlords (non-corporate) before we put in a check request for landlords for the housing assistance program. What are you all doing regarding this issue? If you are not requesting, how you will justify it?

City is going to send W9s to the CBOs but not to the landlords and each organization should follow their own procedures.

#### 6. What evidence, if any, should we ask for?

Evidence will vary depending on how the applicant states he/she was impacted by COVID-19. For instance, if applicant states his/her income decreased as a result of COVID-19, you may wish to ask for a paycheck before COVID-19 and one during COVID-19. If applicant states that he/she had additional childcare costs in order to work, ask for documentation of these additional expenses.

#### 7. Employment status as evidence?

We are providing the funds to you and your organization needs to distribute the funds how you see fit.

#### 8. Can we provide a money-order?

We are providing the funds to you and your organization needs to distribute the funds how you see fit.

#### 9. What about independent contractors, what documentation is used?

## 10.Is an applicant eligible for the City's Housing Retention Grant if the applicant has received other types of funding, such as a stimulus check or disaster relief funds?

Applicants who have received other funding are not ineligible due to CARES Act regulations, but CARES Act funding can only be used to offset, to the extent necessary, any remaining needs. Includes UFW, United Way and other funds.

#### 11. June only eligible?

Yes

#### 12. Future rent eligible (July)?

Since the agreement was drafted in late May, the intent was to offer this for June 1st. There is some wiggle room for July since we are in the middle of July, only with proper documentation - but not beyond July.

### 13.Can this grant be used for future rent noted in Exhibit A. Scope of Services, section 1. (ii) c.?

If the applicant can provide evidence that the grant will be used to prevent eviction or support housing related financial assistance through payment of future rent, it could be eligible under the one-time payment of \$1500 to the individual or \$3000 to the household. However, future rent would not be an eligible expense when the landlord agrees to accept 80% of the rent, since the guidelines state payment is for back rent accruing for the months of April, May, and June.

### 14. What happens if the landlord doesn't want to accept the 80%? Is the applicant ineligible?

The applicant is still eligible for up to \$1,500 as an individual or \$3000 as a household if the landlord is unwilling to accept 80% of the rent.

### a. Does this also imply not to exceed \$1,500 or \$3,000 since the tenant may owe much more, regardless if they accepted the 80%.

If the landlord answers that he/she is willing to accept 80% of back rent from April through June of 2020 as payment in full, it is not capped at \$1,500 per individual or \$3,000 per household. As an example, if tenant owed \$6,000 in back rent from April to June, the landlord may receive \$4,800. In exchange, the landlord is agreeing to the \$4800 as payment in full and furthermore agrees not to raise rent.

If the landlord is willing to accept 80% of back rent for April, May and June the "landlord directly" option should be chosen. If this option is chosen, based on the program structure, the landlord is agreeing to accept less monthly rent than owed, but will be able to obtain more money in the aggregate.

The 80% payment is not capped at \$1,500 for an individual or \$3,000 per household. The landlord would only sign Section 4 if he/she is agreeing to the 80% payment.

The Administrator will provide a check directly to the Landlord in an amount of 80% of Applicant's back rent owed for April, May, and June.

### 15. For clarification, we can't fund applicants who are currently on a mortgage forbearance, is that correct?

Yes, that is correct.

### 16. Can we grant applicants if their mortgage forbearance ends in a couple of months and they are required to make the lump sum payment then?

No.

17.In the case that an applicant applies for assistance with their "temporary forbearance plan" and their documentation states that they do not have to pay for 3 months, they do need to pay the total amount by August 1, 2020. In this case, can they be awarded the amount due up to their limit?

The applicant could be eligible to receive grant funding for the amounts owed in April, May, and June subject to providing all the proper documentation required in the application. An individual would be eligible for up to \$1,500 or \$3000 as a household.

18. In the case that an applicant borrowed money from a family member/friend to pay for the backed up rent, do we make the check directly to the lender? Do we need to provide them with a W-9?

Yes, BUT...

#### 19. Can a custodian/someone's legal advisor be paid directly?

No. They would be considered an applicant.

### 20. How can funds be used for domestic violence victims, is there a separate COVID fund or can the housing grants support?

Focus of this grant is for housing retention due to COVID. CARES funds specific to DV are to be determined. We recommend capturing the need (costs for DV victims to relocate) or we can refer individuals to any homelessness prevention funds available.

### 21.If my husband and I have a joint business that was affected by COVID-19, what evidence is required to show that my business was affected?

This information is not needed for the housing grant, only housing related information.

We firmly believe that this program has the potential to alleviate many hardships that low income rural residents are facing in the wake of the global pandemic.

According to census data, 60% of renters in Fresno County are cost- burdened, and over 75% of lower income residents are paying more than 30% of their income to pay rent. With cases of COVID-19 rising in this county, people out of work, and families struggling to put food on the table it is more important than ever to ensure Fresno County does all it can to ensure people will be able to stay in their homes.

We respectfully request Board of Supervisors expand and strengthen the proposed Housing Retention Program by doing the following to ensure families inFresno County are protected:

- A minimum allocation of \$5 million dollars, similar to the amount allocated for the "Helping Underserved Businesses" grant, as keeping people in their homes should be Fresno County' top priority given the lack of rental protections.
- Preference to Fresno County residents who live in Disadvantaged Unincorporated Communities
- Allow of informal documentation for tenants without a formal lease agreement
- In addition to supporting tenants with past due rent, the program should also protect tenants that will be unable to pay rent on time in the coming months. This will avoid potential three day notices and eviction processing when the Judicial Council orders are lifted.
- Ensure utility payments (water, electricity, etc.) are eligible for funding
- If the funds will be given to landlords, the landlord must be required to provide proof of payment to the tenant
- Landlords must provide documentation to renter that rent was paid
- Remove the affidavit and third party verification requirement for those unable to show proof of loss of income and show documentation of loss of income due to COVID-19
- Ensure that any additional eligibility requirements added will be discussed in a public meeting with input from all stakeholders

We look forward to discussing our suggestions and working together to ensure this program reaches the hundreds of residents in need of assistance.

Dear Supervisor Pacheco:

Tomorrow, the Fresno County Board of Supervisors will be considering implementing a CARES Act small business grant program for local businesses that have been impacted by the COVID-19 pandemic. Fresno PACE is very appreciative of the Board's efforts and commitment to prioritize CARES Act dollars for local businesses in the community.

However, one issue that we would like to bring to your attention is that included as subcategories for eligible "small businesses" are minority-owned businesses and women-owned businesses, which is a very worthwhile element.

Unfortunately, minority and women-owned businesses such as Fresno PACE, which serves lowincome seniors throughout the entire county, will not qualify as a "small business" under the county's grant program and will therefore be shutout of any CARES Act funding opportunities. Please know that there are a number of other minority-owned and women-owned businesses in a similar situation and will also not be eligible for the county's grant program.

#### Consequently, we are respectfully requesting that you direct the county staff to add ADDITIONAL AND SEPARATE GRANT PROGRAM CATEGORIES SPECIFICALLY FOR MINORITY-OWNED BUSINESSES AND WOMEN-OWNED BUSINESSES, regardless of size, be eligible for the county's CARES Act dollars.

These minority and women-owned businesses have been and continue to be financially impacted by COVID-19 and should have the opportunity to apply for the county's CARES Act funding. Having additional and separate minority and women-owned categories would be a reasonable and fair remedy.

As you know, Fresno PACE is community-based, minority and women-owned business and is a comprehensive healthcare program and facility that provides compassionate social, medical and support services to more than 800 low-income vulnerable seniors throughout the County of Fresno. These seniors are some of the most at-risk members in the community for contracting COVID-19.



Like many other minority and women-owned businesses in the county that have been adversely impacted by the pandemic, Fresno PACE continues to provide our much needed services to seniors that rely on our help now more than ever. Since the beginning of the pandemic, we have been working very hard to keep our workers employed and continue to serve the healthcare needs of our most vulnerable senior community members.

Please take the necessary action to prevent Fresno PACE and others from being shut out of pursuing CARES Act funding opportunities. The establishment of separate minority and women-owned business categories, with appropriate funding pools, would remedy this issue.

#### Board Item 5

On behalf of California Rural Legal Assistance Foundation (CRLAF), we support <u>Recommended</u> <u>Action 1. to proposal and possible contract with Centro La Familia for a housing retention</u> <u>program with an emphasis on essential agricultural workers</u> with CARES Act funds. While we support the total amount not to exceed \$250,000, we recommend that the contract be allowed to augment additional funds for the program due the extreme need of financial assistance by impacted farmworkers. The number of farmworkers in Fresno County is about 95,800 that the retention program would need to assist. The county should provide sufficient funds to meet the need.

We also submit additional policy recommendations for the use of the CARES Act funds because Fresno County farmworkers and their families continue to be at risk from COVID-19. Low-income immigrant, farmworkers, including mixed status families are struggling socially and economically during the pandemic.

#### Housing and Immigration Legal Assistance

CRLAF seeks your support to develop a remote legal assistance housing program of low-wage income families and mixed-status families, given the looming housing crisis caused by COVID-19 in Fresno County and the San Joaquin Valley.

The need for free legal consultations and assistance in housing and immigration has been exacerbated by the pandemic. Fresno County low-income immigrant, farmworker and mixed status families need to keep their family unity without fear and threat of eviction and fear of deportation. **Comment:** Dear Board of Supervisors,

On behalf of the Latino Community Foundation, I write in support of Centro La Familia's efforts to implement a housing retention program that provides financial aid for farmworkers that have been affected by COVID-19. Helping these workers cover the cost of housing-related expenses reduces their risk of being evicted or losing their homes in the middle of the current health and economic crisis.

In the last month alone, Fresno County's COVID-19 case count has doubled. In fact, just days ago on August 13<sup>th</sup>, the county reported 752 new cases, the highest number of new cases reported by the county in a single day thus far. Agriculture workers continue to be at high risk for becoming infected. These frontline, essential workers labor long hours in close proximity to other workers, and often live in multifamily housing that facilitates the rapid spread of the virus. Many are also without a legal status, which means they were excluded from the federal relief offered to millions of families earlier this year.

This past March, LCF created the Love Not Fear Fund to support grassroots Latino-led organizations serving Latino and immigrant communities across California. Centro La Familia is one of many organizations in the Fresno Area that we've supported through our philanthropic efforts. In addition to helping the Center maintain its regular services, these funds

were used to assist in food distribution, support residents with essential bills, and assist DACA recipients with filing application fees.

It is for these reasons that I respectfully ask the Fresno Board of Supervisors to work with Centro La Familia to implement a housing retention program that helps essential agriculture workers avoid losing their homes.




