PUBLICATION OF SUMMARY OF PROPOSED ORDINANCE BOARD OF SUPERVISORS COUNTY OF FRESNO

The Fresno County Board of Supervisors is giving notice that at their regularly scheduled meeting on August 5, 2025, at 9:30 a.m., or as soon thereafter as the matter may be heard, at the Fresno County Hall of Records, Board of Supervisors Chambers, 3rd Floor, 2281 Tulare Street, Fresno, California, they will consider adoption of the ordinance summarized below.

SUMMARY OF PROPOSED ORDINANCE

The Ordinance would amend the Fresno County Master Schedule of Fees, Charges and Recovered Costs, by revising Subsections 901 through 904 of Section 900 - Environmental Health (Animal Control Section), to revise unaltered dog license cost and add provisions for a new breeding permit. Subsequently, the numbering sequence would be revised for sections 905 through 960.
