IN THE AMOUNT OF \$2,000,000)

WHEREAS, funding is required to remediate and restore the University Medical Center (UMC) Campus from damage resulting from a power outage emergency that ultimately lead to the loss of electrical power in multiple buildings; and

WHEREAS, said additional costs will be financed by revenue from user County Departments impacted by the power outage and benefiting from our response to said emergency in the amount of \$2,000,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2023-24 Facility Services, Org 8935 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 Facility Services, Org 8935 as follows:


