SHERIFF'S OFFICE DONATION OF THESE BULLET-PROOF )  
VESTS TO ADVANCE ARMENIA FOUNDATION, A 501(c)(3) ) RESOLUTION  
ORGANIZATION )

WHEREAS, Government Code section 25372 provides that the Board of Supervisors may donate or lease any real or personal property that the Board declares to be surplus to any public agency or organization exempt from taxation, which includes, "an organization exempt from taxation pursuant to Section 501(c)(3) of the Internal Revenue Code that is organized to provide health or human services" (Government Code section 25372(b)(5));

WHEREAS, the Sheriff's Office had 291 vests, along with 80 ballistic and stab panels for the vests (Bullet-Proof Vests), that were no longer usable by the County, because the Bullet-Proof Vests had reached their expiration date, a lifecycle of five (5) years;

WHEREAS, Advance Armenia Foundation is an organization exempt from taxation pursuant to Section 501(c)(3) of the Internal Revenue Code that is organized to provide health or human services; and,

WHEREAS, Advance Armenia Foundation represented that it could use these Bullet-Proof Vests, and they would serve to assist Armenia for the purposes of law enforcement and field medical services.

NOW THEREFORE, BE IT RESOLVED that the Fresno County Board of Supervisors hereby retroactively declares that these Bullet-Proof Vests are surplus.

BE IT FURTHER RESOLVED, that the Board of Supervisors hereby ratifies, authorizes, approves on behalf of the County of Fresno the donation of the Bullet-Proof Vests to Advance Armenia Foundation, a 501(c)(3) foundation, for use in general law enforcement services and field medical services.

1 BE IT FURTHER RESOLVED, that the Fresno County Sheriff, or her designee, is hereby  
2 retroactively authorized and directed on behalf of the County of Fresno to execute the donation of  
3 the Bullet-Proof Vests to Advance Armenia Foundation, a 501(c)(3) foundation.
