## SECOND AMENDMENT TO AGREEMENT

THIS SECOND AMENDMENT TO AGREEMENT (hereinafter "Amendment") is made and entered into this <u>I</u> day of June, 2021, by and between COUNTY OF FRESNO, a Political Subdivision of the State of California, Fresno, California (hereinafter "COUNTY"), and FRESNO COUNTY SUPERINTENDENT OF SCHOOLS, a Political Subdivision of the State of California, whose address is 1111 Van Ness Avenue, Fresno, California, 93721 (hereinafter "CONTRACTOR").

## WITNESSETH:

WHEREAS, COUNTY and CONTRACTOR entered into Agreement number D-20-409, dated August 4, 2020, and the First Amendment thereto dated March 5, 2021 (hereinafter collectively "Agreement"), pursuant to which CONTRACTOR agreed to provide COVID-19 medical investigations, contact tracing, and vaccination services to COUNTY; and

WHEREAS, COUNTY and CONTRACTOR extended said Agreement on December 14, 2020 for one (1) additional six (6) month period through June 30, 2021; and

WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement in order to extend the term for one (1) additional six (6) month period through December 31, 2021.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. Section 3 of the Agreement, located on page 2, lines 10 through 14, is deleted in its entirety and replaced with the following:

"The term of this Agreement shall be effective August 4, 2020 through and including December 31, 2021."

COUNTY and CONTRACTOR agree that this Amendment is sufficient to amend the Agreement and, that upon execution of this Amendment, the Agreement and this Amendment together shall be considered the Agreement.

The Agreement, as hereby amended, is ratified and continued. All provisions, terms, covenants, conditions and promises contained in the Agreement and not amended herein shall remain in full force and effect.
