WHEREAS, Probation Org 34409999 requires \$470,000 to meet expenditures for the provision of services related to the implementation of the mandated California Advancing & Innovating Medi-Cal initiative requirements; and

WHEREAS, \$470,000 is available in the fund balance of the Cal AIM Fund 0075, Subclass 17307, Org 1147 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2024-25 adopted appropriations and revenues of Probation Org 34409999; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Probation Org 34409999 as follows:


