WHEREAS, of this amount, \$15,608 is not included in the adopted appropriations and estimated revenues of the District Attorney-Grants Org 2862 for the FY 2018-19; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

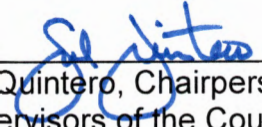

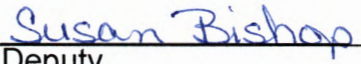
