

SUMMARY
NOTICE is hereby given that at its regularly scheduled meeting on January 12, 2021, the Fresno County Board of Supervisors adopted Ordinance No. 21-002, an Ordinance of the County of Fresno, State of California.
SUMMARY OF ORDINANCE
This Ordinance amends Chapter 17.92 of the Ordinance Code of Fresno County relating to the collection of Clovis Development Fees within the Sphere of Influence of the City of Clovis per the provisions of Sections 4.1.3 and 4.1.4 of Article IV of the City/County Memorandum of Understanding (MOU). On March 16, 2020, the Clovis City Council adopted Resolution No. 20-24, to update the City of Clovis Water Supply Fee. On June 15, 2020, the Clovis City Council adopted Resolution No. 20-78, to update the City of Clovis Master Development Fee Schedule 2020-2021 (which includes the same updated City of Clovis Water Supply Fee as in Clovis City Council Resolution No. 20-24). The City transmitted the signed resolutions (City of Clovis, City Council Resolutions No. 20-24 and No. 20-78) and fee schedules to the County for the County's adoption. The current request is the tenth adjustment to the City's fees since implementation of this process in 2005.
