2210. Exemptions

This Subsection, 2210, does not modify the requirement to obtain listed permits. This Subsection 2210 provides exemptions from the fees associated with the issuance of certain permits under certain prescribed circumstances. The fees specified under Subsection 2201, Paragraph "A" - "Inspection Services - Encroachment Permits;" and under Subsection 2204, "Road Improvement Permits;" will not be imposed when the permit in question is associated with a project that is:

1. to be constructed pursuant to a cooperative project agreement between the County and another public agency, provided that the agency in question has adopted an ordinance or policy whereby it will provide a reciprocal exemption or waiver, as appropriate, of similar fees that otherwise would be charged to the County when mutually engaged with the County in a cooperative road construction project; or,

2. for the improvement of County-owned or County-maintained facilities when such improvement is to be constructed by a contractor retained by the County of Fresno; or,

3. for the relocation, adjustment, improvement, or replacement of utility facilities when such work is requested by the County in connection with a project for the improvement of County-owned or County-maintained facilities.

The permit is required and must be obtained, and in the circumstances specified above the exemption provided applies only to payment of the associated fee; and in those circumstances, it shall be issued as a "no-fee permit."
