Having multiple TSRP providers on a Master Agreement allows the Department the ability to place clients efficiently as needs arise. An agreement with a single provider would limit the department's ability to place clients at an appropriate level of care and would result in higher costs and inappropriate care as clients may need to be placed at higher level programs such as locked Skilled Nursing Facilities or Institutions of Mental Disease

- In an emergency when goods or services are immediately necessary for the preservation of the public health, welfare, or safety, or for the protection of County property.
- When the contract is with a federal, state, or local governmental agency.
- When the department head, with the concurrence of the Purchasing Agent, finds that the cost of preparing and administering a competitive bidding process in a particular case will equal or exceed the estimated contract amount or \$2,500 whichever is more.
- When a contract provides only for payment of per diem and travel expenses and there is to be no payment for services rendered.
- When obtaining the services of expert witnesses for litigation or special counsel to assist the County.
- When in unusual or extraordinary circumstances, the Board of Supervisors or the Purchasing Agent/Purchasing Manager determines that the best interests of the County would be served by not securing competitive bids or issuing a request for proposal.

6. Explain why the unique qualities and/or capabilities described above are essential to your department.  
 TSRP facilities provide a less restrictive level of care to persistent and severely mentally ill adult mental health consumers. TSRP facilities provide services designed to minimize the risk of client hospitalizations and provide enhanced services to assist consumers with developing independent living skills to promote movement toward a less structured setting. Due to the challenging nature of placing clients, a master agreement is critical to ensure clients are placed at the appropriate level of care.
7. Provide a comprehensive explanation of the research done to verify that the recommended vendor is the only vendor with the unique qualities and/or capabilities stated above. Include a list of all other vendors contacted, what they were asked, and their responses.
