RESOURCES CODE, SECTIONS 44307, 44308 AND 44310)

WHEREAS, California Public Resources Code, Section 44308 sets forth procedures for designation of a solid waste independent hearing officer (hearing officer) and requesting and conducting such hearings; and

WHEREAS, on June 14, 1977, the County of Fresno Board of Supervisors adopted Resolution 950-1982, designating the Department of Public Health (DPH) Environmental Health Division (EHD) as the Local Enforcement Agency (LEA) for the County of Fresno, and certified by CalRecycle pursuant to California Public Resources Code, Section 43200, et. seq. and Title 14 of the California Code of Regulations, Section 18051 for the permitting, inspection, and enforcement of solid waste handling and disposal sites; and

WHEREAS, California Public Resources Code, Section 44308 authorizes the County of Fresno Board of Supervisors to appoint a hearing officer to hear appeals received by the LEA pursuant to California Public Resources Code, Section 44307 if it also adopts procedures for making the appointment and adopts qualifications the hearing officer is required to meet; and


WHEREAS, on August 11, 2015, the County of Fresno Board of Supervisors adopted procedures and criteria for the appointment of a hearing officer and qualifications for a hearing officer pursuant to California Public Resources Code, Section 44308(d).

NOW THEREFORE, be it resolved that Mario Reeves, Assistant Agricultural Commissioner/Sealer with the County of Fresno Department of Agriculture and Weights and Measures, is hereby appointed as the hearing officer.
