Resolution

WHEREAS, County Service Area 34 (CSA 34), Org 9174, also known as Millerton New Town provides the funding stream for Millerton Lake pump repairs and capital replacement through Fund 0830, Subclass 16000; and

WHEREAS, the lake pumps provide surface water to the communities of County Service Area 34 (“CSA 34”) Zone A (CSA 34A), Zone C (CSA 34C), Zone D (CSA 34D), Zone F (CSA 34F), and Zone G (CSA 34G), as depicted on attached Exhibit A; and

WHEREAS, CSA 34 experienced lake pump communication failures resulting in a temporary solution; and

WHEREAS, CSA 34 requires an additional \$266,160 to fund the Millerton Lake Pump Communications Project expenditures necessary for a permanent solution to the lake pump communication failure; and

WHEREAS, \$266,160 is available in the general reserves of the CSA 34 Fund 0830, Subclass 16000 to fund these expenditures;

WHEREAS, said monies were not included in the adopted appropriations for the FY 2019-20 CSA. 34, Org 9174; and

WHEREAS, Administrative Officer’s Management Directive 615 provides for the appropriations of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer –Tax Collector is authorized to increase the FY 2019-20 CSA 34 appropriations Fund 0830, Subclass 16000, Org 9174, as follows:




