WHEREAS, the Domestic Violence Org 1123 will receive an additional \$18,702 from marriage license fees and court ordered debt revenues; and

WHEREAS, said monies are not included in the FY 2024-25 adopted appropriations and estimated revenues of the Domestic Violence Org 1123; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Domestic Violence Organization 1123 as follows:
