Dear Members of the Fresno County Board of Supervisors,

I am writing to strongly oppose the proposed policy that would require Board approval for county departments to participate in community events or observances, including Pride Month and related public health outreach.

This policy is a clear step backward for our county. It would give political gatekeepers the power to suppress visibility, outreach, and education efforts that are essential to the health and well-being of LGBTQ+ residents and other marginalized communities. As a Fresno County resident, I believe in a government that serves all its people, not one that picks and chooses whose identities are deemed acceptable for public support.

Supervisor Bredefeld's comments about safer sex materials being distributed at Pride are not only misinformed—they are dangerous. Condoms and lube are not political tools; they are proven public health resources that prevent the spread of HIV and other STDs. This outreach is particularly critical for the LGBTQ+ community, which continues to be disproportionately impacted by health disparities. Undermining that work jeopardizes lives and increases long-term costs for our healthcare system.

Equally concerning is the effort to censor LGBTQ+ displays in libraries and other public spaces. Pride is not political ideology—it is visibility, inclusion, and representation. To silence these expressions while continuing to celebrate other cultural events sends a chilling message that LGBTQ+ people are not welcome or valued.

The job of our public institutions is to serve, educate, and protect. This policy does none of those things. It opens the door to selective censorship, political micromanagement, and discrimination.

I urge you to reject this policy and stand up for the health, dignity, and inclusion of all Fresno County residents.
