WHEREAS, the Fresno County Public Library will purchase “as is” building property, parcel E (APN#447-031-70) from seller in the sum of \$550,000 with closing costs estimates of \$10,000 for total costs \$560,000; and

WHEREAS, said monies are not included in the FY 2023-24 appropriations and withdrawal of funds from Fresno County Library -Measure B fund balance; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 Library Organization 7530 as follows:
