IN THE MATTER OF) MINNEWAWA AVENUE FROM
COUNTY OF FRESNO UNDERGROUND	E. SWIFT AVENUE TO 120 FEET
UTILITY DISTRICT NO. 74	SOUTH OF GETTYSBURG AVENUE

WHEREAS, on September 9, 2025, the Board of Supervisors of the County of Fresno, California, pursuant to the provisions of Fresno County Ordinance No. 470-A-18, adopted its Resolution of Intention to create an underground utility district for the removal of poles, overhead wires and associated overhead structures, along Minnewawa Avenue from E. Swift Avenue to 120 feet south of Gettysburg Avenue; and

WHEREAS, said Resolution of Intention directed the Director of the Department of Public Works and Planning to make and file a report presenting estimates of the extent of the utilities' participation and of time required to remove overhead utilities as shown in the EXHIBIT A.

NOW, THEREFORE, I, Steven E. White, Director of the Department of Public Works and Planning of said County, having consulted with the affected utilities do hereby make the following estimates of time and extent of utility company participation required to complete the work and improvements pursuant to the Resolution of Intention presently on file with the Clerk to the Board of Supervisors and in the County of Fresno Department of Public Works and Planning and incorporated herein by reference:

I. ESTIMATES OF UTILITY COMPANIES' PARTICIPATION:

- A. The Pacific Gas and Electric Company will install all required underground electrical facilities and remove all power poles and associated overhead wires at their expense were within the limits of the road right-of-way, all as more specifically provided for in the State of California Public Utilities Commission's Rule 20.
- B. The Pacific Gas and Electric Company shall use the underground conversion allocation computed pursuant to decisions of the State of California Public Utilities Commission for providing to each premises or electrical user in Underground Utility District No. 74 a maximum of one

 hundred feet of individual electric service trenching and conductor, as well as backfill, paving and conduit, if required.

- C. AT&T will install all required underground telephone distribution facilities and remove all telephone poles and associated overhead wires at their expense within the limits of the Underground Utility District.
- D. Comcast, Inc. will install all required underground cable television distribution facilities and remove all overhead distribution wires at their expense within the limits of the underground utility district including those overhead facilities to individual users who are provided service from within said District.

II. COUNTY OF FRESNO PARTICIPATION:

County of Fresno will incur staff costs for the preparation of a District map and description, hearing process, and the District notification.

III. AFFECTED PROPERTY OWNERS:

As provided for in the Resolution of Intention for Underground Utility District No. 74, Rule 20A conversion allocation funds shall be available for conversion of electric service panels (not to exceed \$1,500 per panel excluding permit fees) to accept the new underground service facilities pursuant to the State of California Public Utilities Commission Rule 20 program. Department of Public Works and Planning staff anticipates that there be <u>no</u> affected property owners requiring conversion.

IV. ESTIMATE OF TIME FOR:

- A. Construction by utility companies complete by: December 31, 2035
- B. Property owner ready date: April 1, 2035

A map entitled "County of Fresno Underground Utility District No. 74", attached hereto and incorporated herein, delineates the boundaries and dimensions of the respective parcels of land within said District indicating thereon all or portions of the affected properties as the same existed in the time of

the passage of said Resolution of Intention, each of which parcels of land having been given a separate number upon said map.

The list of affected property owners within the proposed underground utility district as shown on the last equalized assessment roll for each affected parcel is as set forth in the "List of Affected Property Owners" attached hereto and incorporated herein by reference. For a more particular description of said property, reference is made to the deeds and maps on file and of record in the Office of the County Recorder of the above-stated County and to the notes of said boundary description as set forth in the diagram "County of Fresno Underground Utility District No. 74."




BOUNDARY DESCRIPTION UNDERGROUND UTILITY DISTRICT NO. 74

- THENCE, South 00°33'00" East, a distance of 1910.01 feet, along the West lines of Lot 48, Lot 78, Lot 79, Lot 106, Lot 107, Lot 146, Lot 147, Lot 186 Lot 187, Lot 225, Lot 226, and Lot 238 to the prolongation of the South line of Lot 239 of said Tract No. 1112 Tarpey Village;






