WHEREAS, the Department of Social Services requires \$344,599 to purchase two vans for Outreach services in rural and disaster areas; and

WHEREAS, the Social Services Fund 0065, Subclass 17225, Welfare Advance Fund Organization 1120 will receive funding from the State and Federal government in the amount of \$344,599 in FY 2021-22; and

WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations and estimated revenues of the Welfare Advance Fund Org 1120; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 Welfare Advance Fund Org 1120 as follows:
