AN ORDINANCE AMENDING THE ORDINANCE CODE OF THE COUNTY OF FRESNO THAT AMENDS SECTIONS 2.64.020, 2.64.030 AND 2.64.040 AND ADDING SECTION 2.64.050 OF CHAPTER 2.64 OF TITLE 2 RELATING TO THE ASSESSMENT APPEALS BOARD.

The Board of Supervisors of the County of Fresno ordains as follows:

SECTION 1: Section 2.64.020 is amended to read as follows:

**2.64.020 Board Created**

There is created an assessment appeals board within the county to be designated Assessment Appeals Board No. 1, which board shall consist of five members. This board shall be subject to all of the conditions of, and have all of the duties and powers as provided by, the Constitution and laws of the State of California referred to in Section 2.64.010 of this Chapter as said laws now provide and as they may in the future be amended.

SECTION 2: Section 2.64.030 is amended to read as follows:

**2.64.030 Appointment**

The members of the assessment appeals board shall be appointed directly by the Board of Supervisors. Each Supervisorial District shall nominate one member of the assessment appeals board. The term of each member shall be three years and shall begin on the first Monday in September. Not less than sixty (60) days prior to the expiration of the term of office of any member of the assessment appeals board, the Board of Supervisors shall appoint a person to serve for the succeeding term on said board.

SECTION 3: Section 2.64.040 is amended to read as follows:

**2.64.040 Vacancies**

The Board of Supervisors shall appoint members of the assessment appeals board upon the occurrence of a vacancy on said board. The persons selected to fill the vacancy shall serve

1 the remainder of the unexpired term and shall be nominated by the Supervisorial District that  
2 made the nomination of the member who vacated the office.

3 SECTION 4: Section 2.64.050 is added to read as follows:

4 **2.64.050 Member Attendance at Meetings**

5 Each member of the assessment appeals board is required to attend six (6) meetings per  
6 calendar year. A member shall be deemed to have resigned his or her membership for  
7 absences in excess of two (2) regular meetings in a calendar year. This section is in lieu of  
8 Ordinance Code section 2.68.010.

9 SECTION 5: This ordinance shall supersede the October 3, 1978 Board of Supervisors  
10 Resolution in the matter of appointments to fill vacancies to the Assessment Appeals Board.  
11 This ordinance shall take effect and be in full force and effect thirty (30) days from and after its  
12 passage.
