

Amend the Ordinance Code of Fresno County by amending Title 9 to repeal Chapter 9.04. Sections 9.04.045, 9.04.047, 9.04.049, and amend Sections 9.04.010, 9.04.030, 9.04.040, and 9.04.115, which will better align the requirements of Chapter 9.04 to aid in the enforcement, regulation, and support of proactive measures to mitigate the overpopulation of dogs and cats within Fresno County.
