WHEREAS, the legislation creating Secure Youth Treatment Facilities, Senate Bill 92, gave courts the ability to commit youth to less restrictive programs (LRP) to facilitate safe and successful reintegration of youth into the community (Welfare and institutions Code §875(f)).

WHEREAS, the California Health and Human Services Agency, Office of Youth and Community Restoration (OYCR), is making Less Restrictive Programs Grant funding available to the Fresno County Probation Department, as the implementing agency in Fresno County, to support the development of LRPs to transition youth, as consistent with public safety, to less restrictive programs that encompass employment, behavioral health, and culturally relevant services; and

WHEREAS, the Board of Supervisors of the County of Fresno desires to undertake a certain project designated Transition to Less Restrictive Programs to be funded through the California State General Fund and administered by the California Health and Human Services, Office of Youth and Community Restoration, with the County having oversight and responsibility.

NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Board of Supervisors of the County of Fresno is authorized to execute, on behalf of the County of Fresno, the attached Grant Award and related OYCR-required documents, including any extensions or amendments thereto, subject to approval as to legal form by County Counsel and as to accounting form by the County Auditor.

BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
