WHEREAS, the County has continued a resolution of the local emergency status relating to the extremely high levels of tree mortality and hazardous conditions created by the drought and requested that the Governor continue to provide resources and support to mitigate risks of falling trees and increased fire hazards; and

WHEREAS, the County has applied for and will receive two revenue agreements totaling \$1,390,032 from the California Department of Forestry and Fire Protection Fire Prevention Program Grant; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the Public Works and Planning - Grant Org 5512 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Public Works & Planning - Grant Org 5512 as follows:
