Resolution

WHEREAS, the County of Fresno, Sheriff-Coroner-Public Administrator’s Office has incurred additional salary and benefit costs, one-time services and supplies costs, and annual leave cash-out costs; and

WHEREAS, the Sheriff-Coroner-Public Administrator’s Office requires an additional \$3,479,519 in appropriations to pay for those costs; and

WHEREAS, \$3,479,519 of Unassigned Fund Balance is available in General Fund 0001, Subclass 10000 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2023-24 adopted appropriations of the Sheriff-Coroner-Public Administrator ORG 31114000; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 Sheriff-Coroner-Public Administrator ORG 31114000 as follows:
