WHEREAS, the Environmental Health Surcharges Organization 1157 requires \$30,000 to meet expenditures associated with Quarterly surcharge payments due to the State where estimates are being updated and will follow year-end accrual methodology; and

WHEREAS, \$30,000 is not included in the FY 2019-20 adopted appropriations and estimated revenues of the Environmental Health Surcharges Organization 1157; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Environmental Health Surcharges Organization 1157 as follows:


