

CORONAVIRUS STATE LOCAL FISCAL RECOVERY FUNDS

SUBRECIPIENT AGREEMENT

THIS AGREEMENT ("Agreement") is made and entered into this 3rd day of May, 2022 ("Effective Date"), by and between the COUNTY OF FRESNO, a political subdivision of the state of California ("COUNTY"), and Malaga County Water District, a special district in the County of Fresno formed under Part 2 of Division 12 of the California Water Code, with a district office at 3580 South Frank Street, Fresno, CA 93725 ("SUBRECIPIENT").

WITNESSETH:

WHEREAS, on March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 ("ARPA") which established the Coronavirus State and Local Fiscal Recovery Funds ("SLFRF") Program; and

WHEREAS, the ARPA authorizes the COUNTY to expend SLFRF awarded to the COUNTY for the following eligible purposes, outlined in the Interim Final Rule and Final Rule as follows (each an "Eligible Use," collectively "Eligible Uses"):

- (1) To respond to the COVID-19 public health emergency or its negative economic impacts;
- (2) To respond to workers performing essential work during the COVID-19 public health emergency;
- (3) For the provision of government services to the extent of the reduction in revenue due to the COVID-19 public health;
- (4) To make necessary investments in water, sewer, or broadband infrastructure; and

WHEREAS, the COUNTY intends to allocate a portion of its SLFRF to SUBRECIPIENT for one or more Eligible Uses; and

WHEREAS, the SUBRECIPIENT is the sole service provider of potable water, sewer treatment, and park and recreation services in the Community of Malaga, a Disadvantaged Community of approximately 1,337 residents, located in a census tract with a reported annual median household income of \$41,321; and

WHEREAS, the residents and members of the Malaga, which is the unincorporated community served by the SUBRECIPIENT, were disproportionately impacted by the COVID-19 pandemic; and

1 **WHEREAS**, during the course of the COVID-19 pandemic, California’s severe drought has
2 impacted San Joaquin Valley’s rural communities the most, in particular rural public water systems that
3 solely rely on groundwater pumping to serve its residents; and

4 **WHEREAS**, the Final Rule has designated necessary investment in water infrastructure to be one
5 that meets the eligibility requirements of the Drinking Water State Revolving Fund (DWSRF) as
6 implemented by the Environmental Protection Agency (EPA), including the eligible project category of
7 source projects; and

8 **WHEREAS**, the SUBRECIPIENT represents that its proposed project meets the eligibility
9 requirements of the DWSRF under the eligible project category of source projects, as it would provide
10 an alternative supply in case of emergency or drought; and

11 **WHEREAS**, the Treasury interprets “necessary” investment in infrastructure in the Final Rule to
12 mean: 1) responsive to an identified need to achieve or maintain an adequate minimum level of service,
13 which for some eligible project categories may include a reasonable projection of increased need,
14 whether due to population growth or otherwise and, 2) a cost-effective means for meeting that need,
15 taking into account available alternatives; and

16 **WHEREAS**, the SUBRECIPIENT represents that it is responsible to operate public water system
17 number CA-1010042, which is regulated and permitted by Order Number 03-11-13P-016 issued by the
18 State Water Resources Control Board, Division of Drinking Water; and,

19 **WHEREAS**, the SUBRECIPIENT represents that it operates three underground wells (Wells 6,
20 7, and 8) to supply potable drinking water to the Community of Malaga, and the existing wells are not
21 sufficient to meet Malaga’s maximum day demand if one well were to go out of service; and

22 **WHEREAS**, the SUBRECIPIENT represents that it owns five inactive well site locations,
23 including Well 5, and the land where inactive Well 5 resides has been studied by the SUBRECIPIENT,
24 and SUBRECIPIENT has determined that the location of inactive Well Number 5 is a feasible location to
25 reconstruct a new well site location; and

26 **WHEREAS**, the SUBRECIPIENT represents that a new well properly constructed and developed
27 should produce about 1,200 gallons per minute, which will increase the SUBRECIPIENT’s water supply
28 to meet the maximum day demand, provide a backup supply in case Wells 6, 7, or 8 go out of service,

and improve water availability for the Community of Malaga; and

WHEREAS, the provision of SLFRF to SUBRECIPIENT under this Agreement is intended to support a strong and equitable recovery from the COVID-19 pandemic and economic downturn by making necessary investments in water infrastructure that supports impacted communities and also improves the community's resiliency to the effects of climate change; and

WHEREAS, under Section 602(c)(3) of the ARPA, the COUNTY may transfer SLFRF to special districts (special-purpose unit of local government) for Eligible Uses, for the purpose of meeting ARPA's goals; and

WHEREAS, based on SUBRECIPIENT's representations, COUNTY will grant SLFRF to SUBRECIPIENT so that SUBRECIPIENT may fund the final engineering design, environmental review, Department of Drinking Water permitting, construction and administration, construction review, operation and maintenance manual, and project management for the construction of the new Well 5A, which is necessary to maintain adequate and stable service levels, improve drinking water capacity, and provide an alternative supply in case of emergency or drought in the Community of Malaga ("Program"); and

WHEREAS, COUNTY has determined that the Program to be provided by SUBRECIPIENT is an Eligible Use of SLFRF under the ARPA, in reliance on information provided by SUBRECIPIENT; and

WHEREAS, the COUNTY and SUBRECIPIENT desire to enter into this Agreement so that the COUNTY may provide SLFRF to the SUBRECIPIENT as reimbursement for appropriate and qualifying expenditures, including an Eligible Use of SLFRF, as permitted under the Interim Final Rule and Final Rule.

NOW, THEREFORE, in consideration of the mutual covenants, terms and conditions herein contained, the parties hereto agree as follows:

1. **GENERAL OBLIGATIONS OF THE SUBRECIPIENT**

A. SUBRECIPIENT represents that each of the recitals, stated hereinabove and in Exhibit A to this Agreement, concerning SUBRECIPIENT, and made by SUBRECIPIENT, are true and correct, and that COUNTY may rely upon each of those representations in granting the SLFRF to SUBRECIPIENT under this Agreement.

1 B. SUBRECIPIENT acknowledges that the SLFRF granted under this Agreement are
2 a subaward of SLFRF up to the amount stated herein to carry out the Program.

3 C. SUBRECIPIENT understands and agrees that the SLFRF disbursed under this
4 award may only be spent on documented Eligible Uses in compliance with the ARPA, the United States
5 Department of the Treasury ("TREASURY") regulations implementing section 602 of the ARPA, and
6 guidance issued by the TREASURY regarding the foregoing.

7 D. SUBRECIPIENT represents that it will use these SLFRF to fund the final
8 engineering design, environmental review, Department of Drinking Water permitting, construction,
9 construction administration, construction review, operation and maintenance manual, funding
10 administration, and project management for the construction of the new Well 5A, that is intended to
11 maintain adequate service levels and improve drinking water capacity in the Community of Malaga.

12 E. During the Term of this Agreement, SUBRECIPIENT shall carry out the Program
13 by furnishing to the COUNTY the services described in Exhibit A, Program Description, which is
14 attached and incorporated by this reference.

15 F. Compliance. SUBRECIPIENT is obligated by this Agreement, and is responsible
16 to ensure that SLFRF granted under this Agreement are spent in compliance with all ordinances of the
17 County of Fresno, and laws of the State of California, and all laws of the federal government. This
18 includes, but is not limited to, compliance with all requirements set forth in the Uniform Administrative
19 Requirements, Cost Principles, and Audit Requirements for Federal Awards, 2 CFR Part 200, the
20 TREASURY's Compliance and Reporting Guidance: State and Local Fiscal Recovery Funds
21 ("Compliance Guidance"), Department of the Treasury 31 CFR Part 35 Coronavirus State and Local
22 Fiscal Recovery Funds Interim Final Rule ("Interim Final Rule") (for expenditures before April 1, 2022)
23 and Final Rule ("Final Rule") (for expenditures on April 1, 2022, or later), and any subsequent updates,
24 including TREASURY's Frequently Asked Questions. The award terms and conditions required by the
25 TREASURY are set forth in Exhibit F, which is attached and incorporated by this reference, as provided
26 by the TREASURY. Notwithstanding anything provided in Section 8 of this Agreement, or in this
27 Subsection 1(F), SUBRECIPIENT has the sole responsibility for compliance under this Section 1(F).

28 G. Prevailing Wage.

1 a. For any portion of any of the work, service, and/or function (including, but
2 not limited to, any construction, alteration, installation, demolition, repair, or maintenance work), to be
3 performed, either directly or on behalf of SUBRECIPIENT under any agreements with any contractors
4 and/or suppliers (including their respective sub-contractors at any tier) or otherwise, with respect to the
5 Program that is a “public work” for the purposes of Chapter 1 (commencing with § 1720) of Part 7 of
6 Division 2 of the California Labor Code (collectively, “Chapter 1 of the Labor Code”), (i) SUBRECIPIENT
7 shall comply with, and cause all such contractors and/or suppliers (including their respective sub-
8 contractors at any tier) to comply with, all applicable provisions of Chapter 1 of the Labor Code with
9 respect to the Program, and (ii) prior to causing any work to be performed under any agreements with
10 any contractors and/or suppliers, or otherwise, SUBRECIPIENT shall incorporate all of the provisions of
11 this Section 1.G. into such agreements.

12 b. SUBRECIPIENT shall promptly provide a copy to COUNTY of any
13 correspondence, notices, and/or orders, in any written form, and/or any documents initiating legal action
14 (collectively, “DIR Administrative or Legal Action”) by or on behalf of the Director of the Department of
15 Industrial Relations of the State of California, including any representative thereof (collectively, the
16 “DIR”) to or against SUBRECIPIENT, and SUBRECIPIENT’s written responses, in any written form,
17 thereto, that relate to any work, or any portion thereof, provided however, SUBRECIPIENT’s provision of
18 such copy of any DIR Administrative or Legal Action, and/or SUBRECIPIENT’s responses thereto, or
19 failure to provide same or to timely provide same, shall not impose any obligation upon COUNTY with
20 respect to SUBRECIPIENT’s obligations under this Section 1.G. LESSOR acknowledges that the DIR
21 provides the following internet resource: <https://www.dir.ca.gov/OPRL/DPreWageDetermination.htm>

22 c. COUNTY does not make any representation, or provide any guidance, to
23 SUBRECIPIENT as to (i) the nature, type, or scope of the work, or any portion thereof, to be performed
24 by SUBRECIPIENT, either directly or under any agreements with any contractors and/or suppliers
25 (including their respective sub-contractors at any tier), that constitutes a “public work,” or (ii) the
26 sufficiency of the DIR’s internet resource, above, for purposes of compliance with this Section 1.G. The
27 provisions of this Section 1.G. shall survive the termination of this Agreement.

1 H. Timeline. SUBRECIPIENT shall ensure that the Program is diligently undertaken
2 and completed, and all SLFRF granted under this Agreement are fully expended, no later than
3 December 31, 2026. By August 31, 2024, SUBRECIPIENT shall analyze, and shall report to COUNTY
4 in writing, whether it can complete the Program or fully expend the SLFRF granted under this
5 Agreement by December 31, 2026. If SUBRECIPIENT is not capable of completing the Program or fully
6 expending the SLFRF granted under this Agreement on the Program by December 31, 2026,
7 SUBRECIPIENT shall return any previously issued SLFRF, which have not been bindingly obligated to a
8 permissible use, to COUNTY within fifteen calendar days. Additionally, SUBRECIPIENT shall account
9 for all SLFRF which have not been bindingly obligated to a permissible use by December 31, 2024, and
10 shall remit the same unobligated SLFRF to the COUNTY within thirty calendar days.

11 I. No Litigation. SUBRECIPIENT shall not use any SLFRF provided by the
12 COUNTY in litigation, or to pay any enforcement agency, including, but not limited to, any fines or
13 penalties, or similar charges, and shall notify the COUNTY of any legal action which is filed by or against
14 SUBRECIPIENT. To the extent permitted by law, SUBRECIPIENT shall not institute any action or suit at
15 law or in equity against COUNTY, nor institute, prosecute, or any way aid in the institution or
16 prosecution of any claim, demand, action, or cause of action for equitable relief, damage, loss, or injury
17 either to person or property, or both, whether developed or undeveloped, resulting or to result, known or
18 unknown, past, present, or future, arising out of, in any way, the terms of this Agreement.

19 J. SUBRECIPIENT agrees that if SUBRECIPIENT receives SLFRF from any other
20 local or state entity for all or any part of the Program for which SUBRECIPIENT has received SLFRF
21 from COUNTY under this Agreement, the SUBRECIPIENT shall contact COUNTY in writing within five
22 (5) business days. SUBRECIPIENT agrees that it may be required to return all or part of the SLFRF
23 received from the COUNTY if the total amount of SLFRF from all local and state entities exceeds the
24 Program's budget, and if SUBRECIPIENT does not intend to expand the Program.

25 K. None of the personnel employed in the administration of the Program shall be in
26 any way, or to any extent engaged in, the conduct of political activities prohibited by Chapter 15 of Title
27 5, U.S. Code, as applicable.

1 L. None of the SLFRF to be paid under this Agreement shall be used for any
2 partisan political activity, or to support or defeat legislation pending before Congress.

3 2. **PROCUREMENT REQUIREMENTS**

4 A. SUBRECIPIENT shall comply with all procurement requirements specified in the
5 Uniform Guidance, including, but not limited to, 2 CFR Part 200 et. seq.

6 B. SUBRECIPIENT shall take all necessary affirmative steps to assure that minority
7 businesses, women's business enterprises, and labor surplus area firms are used when possible, when
8 procuring goods and services under this Agreement, including the affirmative steps described in 2 CFR §
9 200.321.

10 C. As appropriate, and to the extent consistent with law, SUBRECIPIENT shall provide a
11 preference for the purchase, acquisition, or use of goods, products, or materials produced in the United
12 States (including but not limited to iron, aluminum, steel, cement, and other manufactured products).

13 D. SUBRECIPIENT agrees to prioritize in its procurement decisions employers who can
14 demonstrate that their workforce meets high safety and training standards (e.g., professional certification,
15 licensure, and/or robust in-house training), that hire local workers and/or workers from historically
16 underserved communities, and who directly employ their workforce or have policies and practices in place
17 to ensure contractors and subcontractors meet high labor standards, and to prioritize employers (including
18 contractors and subcontractors) without recent violations of federal and state labor and employment laws.

19 E. All contracts made by SUBRECIPIENT in excess of \$100,000 with respect to water,
20 sewer, or broadband infrastructure project that involve employment of mechanics or laborers must include a
21 provision for compliance with certain provisions of the Contract Work Hours and Safety Standards Act, 40
22 U.S.C. 3702 and 3704, as supplemented by Department of Labor regulations (29 CFR Part 5).

23 3. **REPORTING REQUIREMENTS**

24 A. **Quarterly Program Expenditure Report:** SUBRECIPIENT shall submit to
25 COUNTY designated contact, as designated by COUNTY's County Administrative Officer in writing at
26 the execution of this Agreement, Quarterly Program Expenditure Reports through the term of this
27 Agreement as provided by this Section 3.A. The reports shall contain, but are not limited to, the
28 information described in Exhibit C, which is attached and incorporated by this reference, and must

1 include a statement, signed by the SUBRECIPIENT, indicating that all expenditures in the report comply
2 with the Interim Rule and the Final Rule, as applicable, and ARPA guidelines for the SLFRF, as set forth
3 by the TREASURY. Quarterly expenditure reports shall be submitted to COUNTY no later than fifteen
4 (15) days after the end of each quarter listed below for the term of this Agreement, beginning with the
5 first quarter ending after the Effective Date:

- 6 1) January 1 – March 31, due by April 15
- 7 2) April 1 – June 30, due by July 15
- 8 3) July 1 – September 30, due by October 15
- 9 4) October 1 – December 31, due by January 15

10 B. **Annual Performance Report:** Within fifteen (15) days after each June 30,
11 SUBRECIPIENT shall submit one “Annual Performance Report” to the COUNTY, covering all
12 performance by the SUBRECIPIENT under this Agreement for the fiscal year ending that June 30. The
13 report shall contain, but not limited to, the information contained in Exhibit D, which is attached and
14 incorporated by this reference.

15 C. **Final Report:** A Final Program Report shall be submitted to COUNTY within thirty
16 (30) days upon completion of the Program. A Final Report shall include an accounting of all costs and
17 expenses incurred by SUBRECIPIENT, and any other information as the COUNTY deems necessary to
18 facilitate closeout of the Program, and ensure COUNTY’s obligations and requirements under the
19 SLFRF Program are met. The Final Program Report is not complete until COUNTY has delivered to
20 SUBRECIPIENT written acceptance of the Final Program Report.

21 4. **NONDISCRIMINATION**

22 A. During any period in which SUBRECIPIENT is in receipt of SLFRF from COUNTY,
23 SUBRECIPIENT and its Board, officers, employees, agents, representatives or subcontractors shall not
24 unlawfully discriminate in violation of any Federal, State or local law, rule or regulation against any
25 employee, applicant for employment or person receiving services under this Agreement because of race,
26 religious creed, color, national origin, ancestry, physical or mental disability including perception of
27 disability, medical condition, genetic information, pregnancy related condition, marital status, gender/sex,
28 sexual orientation, gender identity, gender expression, age (over 40), political affiliation or belief, or military

1 and veteran status. SUBRECIPIENT and its officers, employees, agents, representatives or subcontractors
2 shall comply with all applicable Federal, State and local laws and regulations related to non-discrimination
3 and equal opportunity, including, without limitation, the COUNTY's non-discrimination policy; Title VI of the
4 Civil Rights Act of 1964 (42 U.S.C. sections 2000d et seq.) and TREASURY's implementing regulations at
5 31 C.F.R. Part 22, which prohibit discrimination on the basis of race, color, or national origin under
6 programs or activities receiving federal financial assistance; The Fair Housing Act, Title VIII of the Civil
7 Rights Act of 1968 (42 U.S.C. sections 3601 et seq.), which prohibits discrimination in housing on the basis
8 of race, color, religion, national origin, sex, familial status, or disability; Section 504 of the Rehabilitation Act
9 of 1973, as amended (42 U.S.C. sections 6101 et seq.), and the TREASURY's implementing regulations at
10 31 C.F.R. part 23, which prohibit discrimination on the basis of age in programs or activities receiving
11 federal financial assistance; and Title II of the Americans with Disabilities Act of 1990, as amended (42
12 U.S.C. sections 12101 et seq.), which prohibits discrimination on the basis of disability under programs,
13 activities, and services provided or made available by state and local governments or instrumentalities or
14 agencies thereto; The Fair Employment and Housing Act (Government Code sections 12900 et seq.);
15 California Labor Code sections 1101, and 1102; the Federal Civil Rights Act of 1964 (P.L. 88-352), as
16 amended; and all applicable regulations promulgated in the California Code of Regulations or the Code of
17 Federal Regulations.

18 B. SUBRECIPIENT shall include the non-discrimination and compliance provisions of
19 this Section 4 in all subcontracts to perform work under this Agreement.

20 C. SUBRECIPIENT shall provide a system by which recipients of service shall have the
21 opportunity to express, and have considered, their views, grievances, and complaints regarding
22 SUBRECIPIENT's delivery of services.

23 5. **CONFLICTS OF INTEREST; ETHICS**

24 A. SUBRECIPIENT understands and agrees that it must maintain a conflict-of-interest
25 policy consistent with 2 CFR § 200.318(c), and that such conflict-of-interest policy is applicable to each
26 activity funded under this award. Subrecipient must disclose in writing to the TREASURY and to COUNTY
27 any potential conflict of interest affecting the awarded SLFRF in accordance with 2 CFR § 200.12. Further,
28 no officer, agent, consultant, or employee of SUBRECIPIENT may seek or accept any gifts, service, favor,

1 employment, engagement, remuneration, or economic opportunity which would tend to improperly to
2 influence a reasonable person in that position to depart from the faithful and impartial discharge of the
3 duties of that position.

4 B. No officer, agent, consultant, or employee of SUBRECIPIENT may use his or her
5 position to secure or grant any unwarranted privilege, preference, exemption, or advantage for himself or
6 herself, any member of his or her household, any business entity in which he or she has a financial interest,
7 or any other person.

8 C. No officer, agent, consultant, or employee of SUBRECIPIENT may participate as an
9 agent of SUBRECIPIENT in the negotiation or execution of any contract between SUBRECIPIENT and any
10 private business in which he or she has a financial interest.

11 D. No officer, agent, consultant, or employee of SUBRECIPIENT may suppress any
12 report or other document because it might tend to affect unfavorably his or her private financial interests.

13 E. No officer, agent, consultant, employee, or elected or appointed official of the
14 COUNTY, or SUBRECIPIENT, shall have any interest, direct or indirect, financial, or otherwise, in any
15 contract, subcontract, or agreement with respect thereto, or the proceeds thereof, either for himself or
16 herself, or for those whom he or she has family or business ties, during his or her tenure, or for one year
17 thereafter, for any of the work to be performed pursuant to the Program.

18 6. **REQUIRED LICENSES, CERTIFICATES, AND PERMITS**

19 A. Any licenses, certificates or permits required by the federal, state, county, or municipal
20 governments for SUBRECIPIENT to provide the services and operate the Program described in Exhibit A
21 must be procured by SUBRECIPIENT, and be valid at the time SUBRECIPIENT enters into this
22 Agreement.

23 B. SUBRECIPIENT must maintain such licenses, certificates and permits in full force and
24 effect. Licenses, certificates and permits may include, but are not limited to, driver's licenses, professional
25 licenses or certificates, and business licenses. Such licenses, certificates, and permits will be procured and
26 maintained by SUBRECIPIENT at no expense to the COUNTY.

27 C. Subrecipient must show proof of an established "indirect cost rates," as defined by the
28 Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards, (5

U.S.C. 301; 2 CFR 200) with either the Federal Government, or a final negotiated “indirect cost rate” with COUNTY that complies with the Uniform Guidelines within 3 months of receipt of SLFRF.

7. **OFFICE SPACE, SUPPLIES, EQUIPMENT, AND OPERATING OVERHEAD**

SUBRECIPIENT shall provide all office space, supplies, equipment, vehicles, reference materials, and telephone service necessary for SUBRECIPIENT to provide the services and operate the Program identified in Exhibit A to this Agreement. COUNTY is not obligated to reimburse or pay SUBRECIPIENT for any expense or cost incurred by SUBRECIPIENT in procuring or maintaining such items. Responsibility for the costs and expenses incurred by SUBRECIPIENT in providing and maintaining such items is the sole responsibility and obligation of SUBRECIPIENT, and if funded by SLFRF, shall comply with the Uniform Cost Administrative Principles, and Audit Requirements for Federal Awards.

8. **SUBRECIPIENT’S ACKNOWLEDGEMENT OF COUNTY’S REPORTING TO TREASURY**

A. SUBRECIPIENT acknowledges that COUNTY is obligated to comply with TREASURY’s Compliance and Reporting Guidance, which includes submitting mandatory periodic reports to TREASURY.

B. SUBRECIPIENT acknowledges that COUNTY is accountable to the TREASURY for SUBRECIPIENT oversight, including ensuring SUBRECIPIENT’s compliance with the SLFRF program, SLFRF Award Terms and Conditions, Treasury’s Interim Final Rule or Final Rule, as applicable, and reporting requirements, as applicable.

C. Notwithstanding anything to the contrary in this Section 8, (i) SUBRECIPIENT’s compliance with ARPA and this Agreement are a pre-condition to COUNTY’s obligations under Subsections A and B of this Section 8, (ii) nothing in Subsections A or B of this Section 8 relieve SUBRECIPIENT of its obligations under ARPA and this Agreement, and (iii) Subsections A and B of this Section 8 are for the purpose of informing SUBRECIPIENT that COUNTY has certain obligations to TREASURY, the performance of which depend on SUBRECIPIENT’s compliance with ARPA and this Agreement, and in no way create any enforceable obligation by SUBRECIPIENT against COUNTY.

9. **PENALTIES**

SUBRECIPIENT acknowledges that under ARPA, failure to comply with the restrictions on use as described herein, may result in the TREASURY’s recoupment of SLFRF from the COUNTY, and that in

1 such an event, COUNTY would recoup the SLFRF from SUBRECIPIENT.

2 SUBRECIPIENT also acknowledges that if SUBRECIPIENT fails to comply with the U.S.
3 Constitution, Federal statutes, regulations or the terms and conditions of this Federal award, the COUNTY
4 may impose additional conditions, as described in 2 CFR § 200.208. If the COUNTY determines that
5 noncompliance cannot be remedied by imposing additional conditions, the COUNTY may take one or more
6 of the following actions, as appropriate in the circumstances:

7 A. Demand repayment of SLFRF issued to SUBRECIPIENT. SUBRECIPIENT shall
8 refund SLFRF upon demand by COUNTY.

9 B. Temporarily withhold cash payments pending correction of the deficiency by
10 SUBRECIPIENT, or more severe enforcement action by the COUNTY;

11 C. Disallow (that is, deny both use of funds and any applicable matching credit for) all
12 or part of the cost of the activity or action not in compliance;

13 D. Wholly or partly suspend or terminate the SLFRF;

14 E. Recommend the TREASURY initiate suspension or debarment proceedings;

15 F. Withhold further SLFRF for the Program; and

16 G. Take other remedies that may be legally available.

17 10. **FINANCIAL MANAGEMENT**

18 A. All of the SLFRF received by SUBRECIPIENT shall be maintained by
19 SUBRECIPIENT in a separate account (the "SLFRF Account"), which shall be distinct from any and all
20 other accounts or funds of the SUBRECIPIENT, and any interest, income, or increase in such SLFRF as
21 a result of any investment thereof shall be maintained in such SLFRF Account for the sole authorized
22 use under this Agreement, provided that, in the event SUBRECIPIENT has more than one authorized
23 use of such SLFRF under this Agreement, SUBRECIPIENT may have such number of such separate
24 accounts that correspond to each such authorized use provided further that such separate accounts are
25 subject to this Section 10.A., and are segregated and identified by a unique identifier. In no event shall
26 any such SLFRF be placed in any investment that may be withdrawn only upon payment of penalty, fee,
27 or charge.

1 B. SUBRECIPIENT must provide to COUNTY evidence of SUBRECIPIENT's
2 financial accountability. SUBRECIPIENT shall comply with all applicable Uniform Guidance
3 requirements. SUBRECIPIENT shall consult with COUNTY if SUBRECIPIENT is not certain which
4 Uniform Guidance requirements apply or how they apply.

5 C. Pursuant to 2 CFR 200.303, the SUBRECIPIENT shall develop and implement
6 written internal controls that are effective to ensure that funding decisions under the SLFRF constitute
7 Eligible Uses of SLFRF, and shall document all funding decisions. Upon request by COUNTY, the
8 SUBRECIPIENT shall provide the written internal controls and documentation of funding decisions to
9 the COUNTY.

10 D. SUBRECIPIENT shall submit to the COUNTY a copy of SUBRECIPIENT's most
11 recent single audit under 2 CFR Part 200, or a certification that SUBRECIPIENT expended less than
12 \$750,000 of Federal funds during that reporting period. If SUBRECIPIENT submits a letter stating it
13 expended less than \$750,000 in Federal funds, SUBRECIPIENT shall provide a recent financial
14 statement certified by an appropriate officer or employee of the SUBRECIPIENT. Financial
15 accountability submissions shall be provided to County of Fresno, County Administrative Office located
16 at 2281 Tulare, Room 304, Fresno, CA 93721, or electronically to e-mail address
17 fresnocalo@fresnocountyca.gov.

18 E. SUBRECIPIENT certifies that neither it, nor its principals, are presently debarred,
19 suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this
20 transaction by any federal department or agency. This certification is made pursuant to the regulations
21 implemented by 2 CFR Part 200, Subpart 200.214, Debarment and Suspension, and any relevant
22 program-specific regulations. This provision shall be required of every subcontractor receiving any
23 payment in whole or in part from Federal funds.

24 F. SUBRECIPIENT shall record all costs of the Program by budget line items, which
25 shall be supported by adequate source documentation, including payroll ledgers, time records, invoices,
26 contracts, vouchers, orders, and other accounting documents evidencing in proper detail the nature and
27 propriety of all costs. At any time during normal business hours, SUBRECIPIENT's financial transactions
28 with respect to the Program may be audited by the COUNTY or independent auditors contracted by the

COUNTY, or any combination thereof. The representatives of the auditing agency or agencies shall have access to all books, documents, accounts, records, reports, files, papers, things, property, contractors of program services, and other persons pertaining to such financial transactions and necessary to facilitate the audit.

G. Copies, excerpts, or transcripts of all of the books, documents, papers, and records, including invoices, payroll registers, time records, invoices, contracts, and accounting documents concerning matters that are reasonably related to the Program shall be provided upon request to the COUNTY.

H. Expenditures eligible for reimbursement from the SLFRF are described in Exhibit B, which is attached and incorporated by this reference. SUBRECIPIENT shall not make any changes in the line-item expenditures in Exhibit B without prior written approval of the COUNTY.

I. No cash reimbursement for purchases of any kind is allowable.

11. **TERM**

The term of this Agreement shall comply with ARPA Guidelines, and shall commence on the Effective Date, until COUNTY has delivered to SUBRECIPIENT written acceptance of the Final Program Report under section 3.C. of this Agreement, unless sooner terminated as provided herein. Notwithstanding timelines provided in this Agreement, SUBRECIPIENT may only use ARPA SLFRF to cover costs incurred during the time period set forth by the TREASURY. The COUNTY's written acceptance of the Final Program Report under section 3.C of this Agreement shall include the COUNTY's written notification to the SUBRECIPIENT, on behalf of COUNTY, that the Agreement term has ended. The County Administrative Officer or his or her designee is authorized to execute this written acceptance of the Final Program Report and notification of term end to SUBRECIPIENT.

12. **TERMINATION**

A. **Non-Allocation of Funds:** The terms of this Agreement, and the services to be provided hereunder, are contingent on the approval of funds by the appropriating government agency. Should sufficient funds not be allocated, the services provided may be modified, or this Agreement terminated by COUNTY, at any time without penalty to COUNTY by giving the SUBRECIPIENT thirty (30) days advance written notice.

1 B. Breach of Contract: The COUNTY may immediately suspend or terminate this
2 Agreement in whole or in part, where in the determination of the COUNTY there is:

- 3 1) An illegal or improper use of funds;
4 2) A failure to comply with any term of this Agreement;
5 3) A substantially incorrect or incomplete report submitted to the COUNTY;
6 4) Improperly performed service.

7 In no event shall any payment by the COUNTY constitute a waiver by the COUNTY of any breach
8 of this Agreement or any default which may then exist on the part of the SUBRECIPIENT. Neither shall
9 such payment impair or prejudice any remedy available to the COUNTY with respect to the breach or
10 default. The COUNTY shall have the right to demand of the SUBRECIPIENT the repayment to the
11 COUNTY of any SLFRF disbursed to the SUBRECIPIENT under this Agreement, which in the judgment of
12 the COUNTY were not expended in accordance with the terms of this Agreement. The SUBRECIPIENT
13 shall promptly refund any such SLFRF upon demand.

14 C. Without Cause: Under circumstances other than those set forth above, this
15 Agreement may be terminated by COUNTY by giving thirty (30) days advance written notice of an intention
16 to terminate to SUBRECIPIENT.

17 13. **GRANT FUNDING/COMPENSATION**

18 A. The parties understand that funding for this Agreement is SLFRF provided pursuant to
19 ARPA, codified at Title 31 CFR Part 35, and any amendments thereafter. COUNTY agrees to grant
20 SUBRECIPIENT, and SUBRECIPIENT agrees to receive such grants, up to the total SLFRF grant, in an
21 amount not to exceed one million eight hundred fifty thousand dollars (\$1,850,000).

22 It is expressly agreed and understood that the total amount of SLFRF to be granted by COUNTY to
23 SUBRECIPIENT for the Program shall not exceed one million eight hundred fifty thousand dollars
24 (\$1,850,000) to construct a new well site location (Well 5A), which is intended to respond to the drinking
25 water needs of the community, to maintain adequate service levels, and to improve drinking water capacity
26 in the Disadvantaged Community of Malaga, which is an eligible use under the Final Rule. Drawdown
27 requests for the COUNTY to make a payment shall be in accordance with the sample Drawdown Request
28 Form, attached as Exhibit B, and incorporated by this reference. Drawdowns for the payment of eligible

1 necessary expenses shall include copies of purchase orders, receipts, and reimbursement requests,
2 detailing items purchased, and expenses incurred or anticipated to be incurred in support of the Program
3 for eligible items listed in Table 1-1 of Exhibit B of this Agreement.

4 In the first thirty (30) days following the Effective Date of this Agreement, SUBRECIPIENT may
5 make drawdown requests to a maximum of twenty-five percent (25%) of the Program's total budgeted
6 amount (\$1,850,000) to cover eligible expenditures in support of the Program. The first drawdown request
7 from SUBRECIPIENT to the COUNTY shall also be accompanied by a written certification from the
8 SUBRECIPIENT that the drawdown request for payment is consistent with the amount of work scheduled
9 to be performed with the amount of funding being requested from the COUNTY, and that the drawdown
10 request is in accordance with the Program detailed in Table 1-1 of Exhibit B of this Agreement. After
11 appropriate review and inspection of the first drawdown request, the COUNTY shall make the first
12 payment available to SUBRECIPIENT in a timely manner. After the first drawdown request,
13 SUBRECIPIENT may make additional subsequent drawdown requests to the COUNTY on a quarterly
14 basis (every 90 days) for eligible expenditures to be funded with the remaining balance of the Program's
15 budget in accordance with this Agreement.

16 SUBRECIPIENT must work to minimize the time between the request from the COUNTY and the
17 disbursement of funds to meet the Program needs. Upon receipt of purchase or work orders acceptable to
18 the COUNTY, COUNTY shall grant SLFRF to SUBRECIPIENT. SUBRECIPIENT is responsible for
19 monitoring the Program's cash flow needs and submitting drawdown requests to COUNTY in a timely
20 manner to assure adequate coverage of Program needs. It is understood that all expenses incidental to
21 SUBRECIPIENT's performance of services in carrying out its Program under this Agreement shall be
22 borne by SUBRECIPIENT.

23 SUBRECIPIENT shall submit documentation to the County of Fresno, County Administrative Office
24 located at 2281 Tulare, Room 304, Fresno, CA 93721, or electronically, to e-mail address
25 fresnocal@fresnocountyca.gov. Payment by COUNTY shall be in arrears for services provided during
26 the preceding period of time, within forty-five (45) days from date of receipt, verification and approval of
27 SUBRECIPIENT's invoice and supporting documentation by COUNTY. If SUBRECIPIENT fails to comply
28 with any provision of this Agreement, COUNTY shall be relieved of its obligations for further compensation.

1 B. To ensure compliance with Federal and State regulations, COUNTY may require
2 additional supporting documentation or clarification of claimed expenses as follows:

3 i. COUNTY staff shall notify SUBRECIPIENT to obtain necessary additional
4 documentation or clarification.

5 ii. SUBRECIPIENT shall respond within five (5) business days with required
6 additional documentation or clarification to avoid disallowances/partial payment of invoice.

7 iii. All invoices containing expenses that need additional documentation or
8 clarification not provided to COUNTY within five (5) business days of request shall have those expenses
9 disallowed, and only the allowed expenses shall be paid.

10 iv. SUBRECIPIENT may resubmit disallowed expenses as a supplemental invoice
11 only, and must be accompanied by required documentation.

12 C. All expenses incidental to SUBRECIPIENT'S performance of services in carrying out
13 its Program under this Agreement shall be borne by SUBRECIPIENT. Except as expressly provided in this
14 Agreement, SUBRECIPIENT shall not be entitled to, nor receive from COUNTY, any additional
15 consideration, compensation, salary, wages, or other type of remuneration for services rendered under
16 this Agreement. COUNTY shall not withhold any Federal or State income taxes or Social Security tax from
17 any payments made by COUNTY to SUBRECIPIENT under the terms and conditions of this Agreement.
18 Payment of all taxes and assessments on such sums is the sole responsibility of SUBRECIPIENT. County
19 has no responsibility or liability for payment of SUBRECIPIENT's taxes or assessments.

20 14. **INDEPENDENT CONTRACTOR**

21 In performance of the work, duties and obligations assumed by SUBRECIPIENT under this
22 Agreement, it is mutually understood and agreed that SUBRECIPIENT, including any and all of the
23 SUBRECIPIENT'S officers, agents, and employees will at all times be acting and performing as an
24 independent contractor, and shall act in an independent capacity and not as an officer, agent, servant,
25 employee, joint venturer, partner, or associate of the COUNTY. Furthermore, COUNTY shall have no right
26 to control or supervise or direct the manner or method by which SUBRECIPIENT shall perform its work and
27 function. However, COUNTY shall retain the right to administer this Agreement so as to verify that
28 SUBRECIPIENT is performing its obligations in accordance with the terms and conditions thereof.

1 SUBRECIPIENT and COUNTY shall comply with all applicable provisions of law and the rules and
2 regulations, if any, of governmental authorities having jurisdiction over matters the subject thereof.

3 Because of its status as an independent contractor, SUBRECIPIENT shall have absolutely no right
4 to employment rights and benefits available to COUNTY employees. SUBRECIPIENT shall be solely liable
5 and responsible for providing to, or on behalf of, its employees all legally-required employee benefits. In
6 addition, SUBRECIPIENT shall be solely responsible and save COUNTY harmless from all matters relating
7 to payment of SUBRECIPIENT'S employees, including compliance with Social Security withholding and all
8 other regulations governing such matters. It is acknowledged that during the term of this Agreement,
9 SUBRECIPIENT may be providing services to others unrelated to the COUNTY or to this Agreement.

10 15. **MODIFICATION**

11 Any matters of this Agreement may be modified from time to time by the written consent of all the
12 parties without, in any way, affecting the remainder.

13 16. **NON-ASSIGNMENT**

14 Neither party shall assign, transfer, or sub-contract this Agreement, nor their rights or duties under
15 this Agreement without the prior written consent of the other party.

16 17. **HOLD HARMLESS** SUBRECIPIENT agrees to indemnify, save, hold harmless, and at
17 COUNTY'S request, defend the COUNTY, its officers, agents, and employees from any and all costs
18 and expenses (including attorney's fees and costs), penalties, fines, damages, liabilities, claims, and
19 losses occurring or resulting to COUNTY in connection with the performance, or failure to perform, by
20 SUBRECIPIENT, its officers, agents, or employees under this Agreement, and from any and all costs
21 and expenses (including attorney's fees and costs), penalties, fines, damages, liabilities, claims, and
22 losses occurring or resulting to any person, firm, or corporation who may be injured or damaged by the
23 performance, or failure to perform, of SUBRECIPIENT, its officers, agents, or employees under this
24 Agreement.

25 SUBRECIPIENT shall indemnify COUNTY against any and all actions of recoupment by the
26 TREASURY arising from this Agreement. Such indemnification shall not be limited to the term of this
27 Agreement. SUBRECIPIENT shall indemnify COUNTY against any and all claims or actions by any
28 person or entity arising from any violation or alleged violation of Section 1.G, herein.

1 The provisions of this Section 17 shall survive the termination of this Agreement.

2 18. **INSURANCE**

3 Without limiting the COUNTY's right to obtain indemnification from SUBRECIPIENT or any third
4 parties, SUBRECIPIENT, at its sole expense, shall maintain in full force and effect, the following
5 insurance policies or a program of self-insurance, including but not limited to, an insurance pooling
6 arrangement or Joint Powers Agreement (JPA) throughout the term of the Agreement:

7 A. **Commercial General Liability**

8 Commercial General Liability Insurance with limits of not less than Two Million Dollars
9 (\$2,000,000.00) per occurrence and an annual aggregate of Four Million Dollars (\$4,000,000.00). This
10 policy shall be issued on a per occurrence basis. COUNTY may require specific coverages including
11 completed operations, products liability, contractual liability, Explosion-Collapse-Underground, fire legal
12 liability or any other liability insurance deemed necessary because of the nature of this contract.

13 B. **Automobile Liability**

14 Comprehensive Automobile Liability Insurance with limits of not less than One Million Dollars
15 (\$1,000,000.00) per accident for bodily injury and for property damages. Coverage should include any auto
16 used in connection with this Agreement.

17 C. **Professional Liability**

18 If SUBRECIPIENT employs licensed professional staff, (e.g., Ph.D., R.N., L.C.S.W., M.F.C.C.) in
19 providing services, Professional Liability Insurance with limits of not less than One Million Dollars
20 (\$1,000,000.00) per occurrence, Three Million Dollars (\$3,000,000.00) annual aggregate.

21 SUBRECIPIENT agrees that it shall maintain, at its sole expense, in full force and effect for a
22 period of three (3) years following the termination of this Agreement, one or more policies of
23 professional liability insurance with limits of coverage as specified herein.

24 D. **Worker's Compensation**

25 A policy of Worker's Compensation insurance as may be required by the Labor Code.

26 **Additional Requirements Relating to Insurance**

27 SUBRECIPIENT shall obtain endorsements to the Commercial General Liability insurance naming
28 the County of Fresno, its officers, agents, and employees, individually and collectively, as additional

1 insured, but only insofar as the operations under this Agreement are concerned. Such coverage for
2 additional insured shall apply as primary insurance and any other insurance, or self-insurance, maintained
3 by COUNTY, its officers, agents and employees shall be excess only and not contributing with insurance
4 provided under SUBRECIPIENT's policies herein. This insurance shall not be cancelled or changed without
5 a minimum of thirty (30) days advance written notice given to COUNTY.

6 SUBRECIPIENT hereby waives its right to recover from COUNTY, its officers, agents, and
7 employees any amounts paid by the policy of worker's compensation insurance required by this
8 Agreement. SUBRECIPIENT is solely responsible to obtain any endorsement to such policy that may be
9 necessary to accomplish such waiver of subrogation, but SUBRECIPIENT's waiver of subrogation under
10 this paragraph is effective whether or not SUBRECIPIENT obtains such an endorsement.

11 Within Thirty (30) days from the date SUBRECIPIENT signs and executes this Agreement,
12 SUBRECIPIENT shall provide certificates of insurance and endorsement as stated above for all of the
13 foregoing policies, as required herein, to the County of Fresno, County Administrative Office, Attention:
14 ARPA – SLFRF Coordinator, 2281 Tulare Street, Room 304, Fresno, CA 93721, stating that such
15 insurance coverage have been obtained and are in full force; that the County of Fresno, its officers, agents
16 and employees will not be responsible for any premiums on the policies; that for such worker's
17 compensation insurance the SUBRECIPIENT has waived its right to recover from the COUNTY, its officers,
18 agents, and employees any amounts paid under the insurance policy and that waiver does not invalidate
19 the insurance policy; that such Commercial General Liability insurance names the County of Fresno, its
20 officers, agents and employees, individually and collectively, as additional insured, but only insofar as the
21 operations under this Agreement are concerned; that such coverage for additional insured shall apply as
22 primary insurance and any other insurance, or self-insurance, maintained by COUNTY, its officers, agents
23 and employees, shall be excess only and not contributing with insurance provided under SUBRECIPIENT's
24 policies herein; and that this insurance shall not be cancelled or changed without a minimum of thirty (30)
25 days advance, written notice given to COUNTY.

26 In the event SUBRECIPIENT fails to keep in effect at all times insurance coverage as herein
27 provided, the COUNTY may, in addition to other remedies it may have, suspend or terminate this
28 Agreement upon the occurrence of such event.

1 All policies shall be issued by admitted insurers licensed to do business in the State of California,
2 and such insurance shall be purchased from companies possessing a current A.M. Best, Inc. rating of A
3 FSC VII or better.

4 19. **RECORDKEEPING AND CONFIDENTIALITY**

5 A. Pursuant to the Compliance Guidance published by TREASURY, the SUBRECIPIENT
6 must maintain records and financial documents for five (5) years after all SLFRF have been expended or
7 returned to TREASURY. SUBRECIPIENT acknowledges that the Compliance Guidance published by
8 TREASURY may change, and understands that any changes must be complied with. SUBRECIPIENT is
9 responsible to comply with any changes made to the Compliance Guidance, and COUNTY has no
10 responsibility to notify the SUBRECIPIENT of any changes to the Compliance Guidance by TREASURY.

11 B. SUBRECIPIENT shall maintain reasonable security measures to protect records
12 containing personal information from unauthorized access, acquisition, destruction, use, modification, or
13 disclosure pursuant to California Consumer Privacy Act (CCPA) to ensure against a breach of security
14 of personal information of clients, staff, or other individuals. SUBRECIPIENT shall have established
15 written policies and procedures that align with CCPA, and shall follow such procedures. Upon request,
16 SUBRECIPIENT shall make available to COUNTY staff such written policies and procedures, and shall
17 be monitored for compliance.

18 20. **AUDITS AND INSPECTIONS:**

19 A. SUBRECIPIENT shall, at any time during business hours, and as often as the
20 COUNTY may deem necessary, make available to the COUNTY for examination all of its records and data
21 with respect to the matters covered by this Agreement. The SUBRECIPIENT shall, upon request by the
22 COUNTY, permit the COUNTY to audit and inspect all of such records and data necessary to ensure
23 SUBRECIPIENT'S compliance with the terms of this Agreement. SUBRECIPIENT shall allow duly
24 authorized representatives of the COUNTY or independent auditors contracted by the COUNTY, or any
25 combination thereof, to conduct such reviews, audits, and on-site monitoring of the Program as the
26 reviewing entity deems to be appropriate in order to determine:

- 27 1) Whether the objectives of the Program are being achieved;
28 2) Where the Program is being operated in efficient and effective manner;

- 1 3) Whether management control systems and internal procedures have
2 been established to meet the objectives of the Program;
3 4) Whether the financial operations of the Program are being conducted
4 properly;
5 5) Whether the periodic reports to the COUNTY contain accurate and
6 reliable information;
7 6) Whether all of the activities of the Program are conducted in compliance
8 with the provisions of state and federal laws and regulations and this
9 Agreement; and
10 7) Whether all activities associated with the Program are in compliance with
11 the Interim Final Rule and Final Rule for the SLFRF, the Compliance
12 Guidance, and any subsequent guidance issued by TREASURY.

13 B. SUBRECIPIENT shall maintain all books, documents, and other materials relevant to
14 its performance under this Agreement. These records shall be subject to the inspection, review, and audit
15 by the COUNTY or its designees, and the TREASURY, for five (5) years following termination of this
16 Agreement. If it is determined during the course of the audit that the SUBRECIPIENT was reimbursed for
17 unallowable costs under this Agreement, the ARPA Guidelines, or the Final Rule, SUBRECIPIENT agrees
18 to promptly reimburse the COUNTY for such payments upon request.

19 C. SUBRECIPIENT agrees and acknowledges that if SUBRECIPIENT expends more
20 than \$750,000 in Federal awards during a fiscal year, SUBRECIPIENT shall be subject to an audit under
21 the Single Audit Act and its implementing regulation at 2 CFR Part 200, Subpart F, regarding audit
22 requirements.

23 21. **NOTICES** The persons and their addresses having authority to give and receive notices
24 under this Agreement include the following:

1 All notices between the COUNTY and SUBRECIPIENT provided for or permitted under this Agreement
2 must be in writing and delivered either by personal service, by first-class United States mail, by an overnight
3 commercial courier service, or by telephonic facsimile transmission. A notice delivered by personal service
4 is effective upon service to the recipient. A notice delivered by first-class United States mail is effective
5 three COUNTY business days after deposit in the United States mail, postage prepaid, addressed to the
6 recipient. A notice delivered by an overnight commercial courier service is effective one COUNTY business
7 day after deposit with the overnight commercial courier service, delivery fees prepaid, with delivery
8 instructions given for next day delivery, addressed to the recipient. A notice delivered by telephonic
9 facsimile is effective when transmission to the recipient is completed (but, if such transmission is completed
10 outside of COUNTY business hours, then such delivery shall be deemed to be effective at the next
11 beginning of a COUNTY business day), provided that the sender maintains a machine record of the
12 completed transmission. For all claims arising out of or related to this Agreement, nothing in this section
13 establishes, waives, or modifies any claims presentation requirements or procedures provided by law,
14 including but not limited to the Government Claims Act (Division 3.6 of Title 1 of the Government Code,
15 beginning with section 810).

16 22. **GOVERNING LAW**

17 Venue for any action arising out of or related to this Agreement shall only be in Fresno County,
18 California.

19 The rights and obligations of the parties and all interpretation and performance of this Agreement
20 shall be governed in all respects by the laws of the State of California.

21 23. **ADVICE OF ATTORNEY**

22 Each party warrants and represents that in executing this Agreement, it has received
23 independent legal advice from its attorneys, or the opportunity to seek such advice.

24 24. **DISCLOSURE OF SELF-DEALING TRANSACTIONS**

25 This provision is only applicable if the SUBRECIPIENT is operating as a corporation (a for-profit
26 or non-profit corporation) or if during the term of the agreement, the SUBRECIPIENT changes its status
27 to operate as a corporation.

28 Members of the SUBRECIPIENT's Board of Directors shall disclose any self-dealing transactions

1 that they are a party to while SUBRECIPIENT is providing goods or performing services under this
2 agreement. A self-dealing transaction shall mean a transaction to which the SUBRECIPIENT is a party
3 and in which one or more of its directors has a material financial interest. Members of the Board of
4 Directors shall disclose any self-dealing transactions that they are a party to by completing and signing a
5 Self-Dealing Transaction Disclosure Form, attached hereto as Exhibit D and incorporated herein by
6 reference, and submitting it to the COUNTY prior to commencing with the self-dealing transaction or
7 immediately thereafter.

8 25. **ELECTRONIC SIGNATURES**

9 The parties agree that this Agreement may be executed by electronic signature as provided in
10 this section. An “electronic signature” means any symbol or process intended by an individual signing
11 this Agreement to represent their signature, including but not limited to (1) a digital signature; (2) a faxed
12 version of an original handwritten signature; or (3) an electronically scanned and transmitted (for
13 example by PDF document) of a handwritten signature. Each electronic signature affixed or attached to
14 this Agreement (1) is deemed equivalent to a valid original handwritten signature of the person signing
15 this Agreement for all purposes, including but not limited to evidentiary proof in any administrative or
16 judicial proceeding, and (2) has the same force and effect as the valid original handwritten signature of
17 that person. The provisions of this section satisfy the requirements of Civil Code section 1633.5,
18 subdivision (b), in the Uniform Electronic Transaction Act (Civil Code, Division 3, Part 2, Title 2.5,
19 beginning with section 1633.1). Each party using a digital signature represents that it has undertaken
20 and satisfied the requirements of Government Code section 16.5, subdivision (a), paragraphs (1)
21 through (5), and agrees that each other party may rely upon that representation. This Agreement is not
22 conditioned upon the parties conducting the transactions under it by electronic means and either party
23 may sign this Agreement with an original handwritten signature.

24 26. **ENTIRE AGREEMENT:** This Agreement constitutes the entire agreement between the
25 SUBRECIPIENT and COUNTY with respect to the subject matter hereof, and supersedes all previous
26 Agreement negotiations, proposals, commitments, writings, advertisements, publications, and
27 understanding of any nature whatsoever unless expressly included in this Agreement. Notwithstanding this
28 provision, any additional requirements and/or guidelines set forth by the TREASURY regarding the uses

and reporting requirements for ARPA SLFRF after the execution of this Agreement shall be understood to be integrated into this Agreement, and binding on the parties.

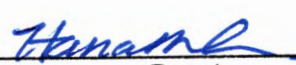

2 **Program Description**

3 SUBRECIPIENT provides domestic water supply regulated by California State Water Resources
4 Control Board, Division of Drinking Water (SWRCB). SUBRECIPIENT is responsible to operate public water
5 system number CA-1010042 under order 03-11-13P-016 issued by SWRCB.

6 SUBRECIPIENT represents that it relies on three underground water wells to supply drinking water
7 to the Disadvantaged Community of Malaga. SUBRECIPIENT represents that its existing three active wells
8 are not sufficient to meet Malaga's maximum day demand of 2,654 gallons per minute (gpm) if one well were
9 to go out of service. The SUBRECIPIENT's existing wells are capable of providing the following flow rates:
10 Well 6 (1,000 gpm); Well 7 (1,000 gpm); and, Well 8 (1,000 gpm). SUBRECIPIENT represents that it owns
11 five inactive well sites, one of which (Well 5) has been studied by the SUBRECIPIENT by drilling a test
12 hole that has resulted with the recommendation to proceed with the replacement of the inactive Well 5.

13 The construction of a new well site at Well 5 will be responsive to an identified need in the
14 Community of Malaga, as it will increase drinking water quality, maintain adequate and stable service
15 levels, provide an alternative supply in case of emergency or drought, and increase drinking water
16 capacity for the Disadvantaged Community of Malaga. SUBRECIPIENT represents that a new well
17 properly constructed and developed at the Well 5 location should produce about 1,200 gallons per minute,
18 thereby increasing the SUBRECIPIENT's water supply to an adequate level to meet the maximum day
19 demand. The Community of Malaga is designated as a Disadvantaged Community, with an average median
20 household income of \$41,321 (census tract 06019001500).

EXHIBIT B

Subrecipient Expenditure Plan

SUBRECIPIENT shall provide to COUNTY drawdown requests for payments for eligible expenses to complete the Program. In the first thirty (30) days following the Effective Date of this Agreement, SUBRECIPIENT may make drawdown requests to a maximum of four hundred sixty-two thousand, five hundred dollars (\$462,500), equivalent to twenty-five percent (25%) of the Program's total budgeted amount (\$1,850,000), to cover eligible expenditures in support of the Program. Drawdown requests shall be made on a quarterly basis (every 90 days) thereafter. SUBRECIPIENT shall use the Drawdown Request Form to submit detailed drawdown requests for eligible expenses and include copies purchase orders, receipts, and reimbursement requests, detailing items purchased, and expenses incurred or anticipated to be incurred in support of the Program as represented in Table 1-1, below.

13 of continued receipt of federal financial assistance and is binding upon Subrecipient and
14 Subrecipient's successors, transferees, and assignees for the period in which such assistance is
15 provided.
- 16 5. Subrecipient acknowledges and agrees that it must require any sub-grantees, contractors,
17 subcontractors, successors, transferees, and assignees to comply with assurances 1-4 above, and
18 agrees to incorporate the following language in every contract or agreement subject to Title VI and
19 its regulations between the Subrecipient and the Subrecipient's sub-grantees, contractors,
20 subcontractors, successors, transferees, and assignees:

21 *The sub-grantee, contractor, subcontractor, successor, transferee, and assignee shall*
22 *comply with Title VI of the Civil Rights Act of 1964, which prohibits subrecipients of federal*
23 *financial assistance from excluding from a program or activity, denying benefits of, or*
24 *otherwise discriminating against a person on the basis of race, color, or national origin (42*
25 *U.S.C. § 2000d et seq.), as implemented by the Department of the Treasury's Title VI*
26 *regulations, 31 CFR Part 22, which are herein incorporated by reference and made a part of*
27 *this contract (or agreement). Title VI also includes protection to persons with "Limited*
28 *English Proficiency" in any program or activity receiving federal financial assistance , 42*

1 *U.S.C. § 2000d et seq., as implemented by the Department of the Treasury's Title VI*
2 *regulations, 31 CFR Part 22, and herein incorporated by reference and made a part of this*
3 *contract or agreement.*

- 4 6. Subrecipient understands and agrees that if any real property or structure is provided or improved
5 with the aid of federal financial assistance by the Department of the Treasury, this assurance
6 obligates the Subrecipient, or in the case of a subsequent transfer, the transferee, for the period
7 during which the real property or structure is used for a purpose for which the federal financial
8 assistance is extended or for another purpose involving the provision of similar services or benefits.
9 If any personal property is provided, this assurance obligates the Subrecipient for the period during
10 which it retains ownership or possession of the property.
- 11 7. Subrecipient shall cooperate in any enforcement or compliance review activities by the Department
12 of the Treasury of the aforementioned obligations. Enforcement may include investigation,
13 arbitration, mediation, litigation, and monitoring of any settlement agreements that may result from
14 these actions. The Subrecipient shall comply with information requests, on-site compliance reviews
15 and reporting requirements.
- 16 8. Subrecipient shall maintain a complaint log and inform the Department of the Treasury of any
17 complaints of discrimination on the grounds of race, color, or national origin, and limited English
18 proficiency covered by Title VI of the Civil Rights Act of 1964 and implementing regulations and
19 provide, upon request, a list of all such reviews or proceedings based on the complaint, pending or
20 completed, including outcome. Subrecipient also must inform the Department of the Treasury if
21 Subrecipient has received no complaints under Title VI.
- 22 9. Subrecipient must provide documentation of an administrative agency's or court's findings of non-
23 compliance of Title VI and efforts to address the non-compliance, including any voluntary
24 compliance or other agreements between the Subrecipient and the administrative agency that
25 made the finding. If the Subrecipient settles a case or matter alleging such discrimination, the
26 Subrecipient must provide documentation of the settlement. If Subrecipient has not been the subject
27 of any court or administrative agency finding of discrimination, please so state.
- 28

1 10. If the Subrecipient makes sub-awards to other agencies or other entities, the Subrecipient is
2 responsible for ensuring that sub-recipients also comply with Title VI and other applicable
3 authorities covered in this document State agencies that make sub-awards must have in place
4 standard grant assurances and review procedures to demonstrate that that they are effectively
5 monitoring the civil rights compliance of subrecipients.
6

7 The United States of America has the right to seek judicial enforcement of the terms of this assurances
8 document, and nothing in this document alters or limits the federal enforcement measures that the United
9 States may take in order to address violations of this document or applicable federal law.
