RESOLUTION

WHEREAS, the Fresno County Public Library and Public Works requires to established appropriations in the amount of \$6,000,000 under Capital Projects fund 0400, Subclass 10073, Capital Outlay Organization 8873 Selma branch library, Project 92036 for branch improvements. Public Works and Planning Department administers the Capital Project Fund 0400, which contains the financing for the project; and

WHEREAS, the Board of Supervisors allocated \$6,000,000 of the Library Fund Balance to finance the project adopted appropriations from Fund 0107 Library Measure B, Library Capital Improvements Organization 7530, Account 7910-Operating Transfer Out to fund the project under Budget transfer number 37; and

WHEREAS, said monies are not included in the FY 2024-25 appropriations and estimated revenues of the Capital Projects – Selma Branch Library Improvements – Organization 8873; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 as follows:


