WHEREAS, the FY 2024-25 adopted budget of the Welfare Advance Fund Org 1120 includes appropriations based upon collection of State and Federal welfare assistance and welfare administration revenues; and

WHEREAS, the State of California has reduced the allocation to the Housing and Disability Advocacy Program; and

WHEREAS, said non collection of revenues requires the reduction of appropriations and estimated revenues; and

WHEREAS, Section 29126.1 of the Government Code authorizes the Board of Supervisors to cancel any unused appropriations and estimated revenues;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to decrease the appropriations in the FY 2024-25 Welfare Advance Fund Org 1120 as follows:


