

NOTICE is hereby given that at its regularly scheduled meeting on May 20, 2025, the Fresno County Board of Supervisors adopted Ordinance No. 25-011, an Ordinance of the County of Fresno, State of California.
SUMMARY OF ORDINANCE
This Ordinance amends the Fresno County Master Schedule of Fees, Charges and Recovered Costs, by amending Section 1000 for Computer Services (EMIS), subsection 1001, Section 1500 for Parks and Recreation, subsection 1509, Section 2200 for Public Works, subsections 2203, 2207, 2208, and 2209, and Section 2500 for Development Services related to recovery of costs for services provided by the County.
