The Housing and Disability Advocacy Program (HDAP) was established by the California Department of Social Services (CDSS) and requires unique components including Disability Benefits Advocacy, Medical Care Coordination & Support, Assessment of Referrals & Client Intake, Housing Case Management, Housing & Client Financial Assistance, Exit Transition Planning, and Outreach. Additionally, requires experience in implementing disability benefits application data as part of the SSI/SSDI Outreach, Access, and Recovery (SOAR) model, and the Fresno Madera Continum of Care (FMCoC) Homesless Management Information System (HMIS) project.

  - With an ongoing need for services to address individuals experiencing homelessness or at risk of being homeless in the County of Fresno, HDAP is administered through the Department of Services to provide assistant individuals who are homeless or at risk of becoming homeless with applying for disability benefit programs and providing housing support.

WestCare, Inc. currently is the only vendor able to provide Disability Benefits Advocacy, Medical Care Coordination & Support, Assessment of Referrals & Client Intake, Housing Case Management, Housing & Client Financial Assistance, Exit Transition Planning, and Outreach services because the housing disability advocacy program is a pilot program established based off state legislation. Other vendors were not contacted for this agreement as this program is still in its infancy and WestCare developed their module specific to state-required program needs. As we continue to monitor the program's implementation and efficacy, it is in the best interest of our clients to maintain level and consistent care by utilizing the same vendor that initiated the program.
