Board of Supervisors' Committee Reports and Comments

11. Board of Supervisors' Committee Reports and Comments - Receive and provide direction (this item reserved for committee reports by members of the Board of Supervisors)

SUPERVISOR MENDES ADDRESSED THE FUNDING PLAN FOR A COUNTY ANIMAL FACILITY AND QUESTIONED IF THE PLAN IS TO BUILD A COUNTY FACILITY. SUPERVISOR MAGSIG ACKNOWLEDGED THAT THE COUNTY IS NOT WAITING AND IS ACTIVELY LOOKING AT SITES THAT MAY BE APPROPRIATE TO LOCATE A FACILITY, BUT IS BEING PROACTIVE TO FIND A SITE BEST SUITED FOR EVERYONE. SUPERVISOR MENDES COMMENTED HE BELIEVES THE PUBLIC IS CONFUSED AND THINKS THE FACILITY WILL BE A COUNTY FACILITY, WHICH IT IS NOT. COUNTY COUNSEL DANIEL CEDERBORG STATED THIS MAY BE A GOOD OPPORTUNITY FOR THE BOARD TO DIRECT THE COUNTY ADMINISTRATIVE OFFICER TO CREATE A FUTURE AGENDA ITEM TO DISCUSS DIRECTION TO STAFF ON THE COUNTY ANIMAL SHELTER. SUPERVISOR BORGEAS RECOGNIZED THIS MORNING'S 9/11 COMMEMORATION EVENT AS VERY IMPRESSIVE WITH MANY MEMBERS OF THE COUNTY SHOWING THEIR SUPPORT. FOLLOWING A MEETING HE HELD WITH FRESNO LEAGUE OF WOMAN VOTERS, SUPERVISOR BORGEAS ASKED JEAN ROUSSEAU, COUNTY ADMINISTRATIVE OFFICER, IF THERE IS A TIMELINE FOR THE FIRST PUBLIC MEETING OF THE COUNTY GENERAL PLAN AND IS THE COUNTY PUBLIC INFORMATION OFFICER BEING TASKED WITH FINDING CREATIVE AND COST EFFECTIVE WAYS OF PUTTING THE MESSAGE OUT FOR THE PUBLIC MEETING. JEAN ROUSSEAU RESPONDED HE HADN'T DISCUSSED THE MEETINGS WITH PUBLIC WORKS DIRECTOR STEVEN WHITE, BUT HAS TASKED JORDAN SCOTT, PUBLIC INFORMATION OFFICER, TO REACH OUT TO THE DEPARTMENT AND OFFER HIS SERVICES. SUPERVISOR BORGEAS EMPHASIZED THE IMPORTANCE OF A VERY ROBUST COMMUNITY OUTREACH EFFORT AND ASSURING PEOPLE HAD THE MEANS TO LEARN ABOUT THE EVENT. SUPERVISOR BORGEAS STATED THE GENERAL PLAN BEING REFERRED TO AS THE 2040 PLAN AND ASKED DANIEL CEDERBORG, COUNTY COUNSEL, THE LEGAL CONSEQUENCES OF REFERRING TO THE GENERAL PLAN AS AN UPDATE OR REVISION AND THE USE OF THE TERM 2040. DANIEL CEDERBORG STATED THAT HE WOULD REVIEW AND PROVIDE ADVICE TO THE BOARD. SUPERVISOR BORGEAS ANNOUNCED HE HAD A CONVERSATION WITH SUPERVISOR MENDES AND THEY ARE PREPARING TO BRING AN ITEM FOR THE BOARD TO CONSIDER, BUT WANTED TO BRING IT TO THEIR ATTENTION BECAUSE OF THE RURAL COUNTY REPRESENTATIVES OF CALIFORNIA (RCRC) CONFERENCE SCHEDULED NEXT WEEK. THE ITEM WILL ADDRESS WHETHER OR NOT THE BOARD WANTS TO ADVOCATE AS A COUNTY TO PURSUE A WAY OF CHANGING THE STATE WATER BOARD COMPOSITION FROM A GUBERNATORIAL APPOINTMENT TO AN ELECTED APPOINTMENT, AND IF THERE IS ANY INTEREST TO BRING IT UP WITH OTHER COUNTIES AT RCRC OR CALIFORNIA STATE ASSOCIATION OF COUNTIES (CSAC). SUPERVISOR MAGSIG REPORTED THAT HE ALSO MET WITH FRESNO LEAGUE OF WOMEN VOTERS AND REQUESTED THEY PUT TOGETHER A LETTER OR LIST OF CONCERNS TO THE BOARD AT A PUBLIC MEETING SINCE THAT IS THE ONLY TIME THE FIVE BOARD MEMBERS, OR A MAJORITY OF BOARD MEMBERS, CAN DISCUSS ITEMS. HE CHALLENGED THE GROUP ABOUT TIME FRAMES BECAUSE HE RESEARCHED THE GENERAL PLAN, AND ONE PARTICULAR ISSUE REGARDING 2040 WAS ACTUALLY DISCUSSED IN 2015, WITH MEETING MINUTES REFLECTING THE DISCUSSION, SO THERE NEEDS TO BE CREDIBILITY IN THE PROCESS FOR ALL PARTIES – THE COUNTY AND INTERESTED PARTIES. SUPERVISOR MAGSIG MENTIONED THAT STAN KING, A LONGTIME RODEO ASSOCIATION MEMBER OF CLOVIS AS WELL AS A MAYOR OF CLOVIS, PASSED AWAY AND A MEMORIAL RESOLUTION WILL BE PREPARED TO HONOR HIM AT THE NEXT BOARD MEETING

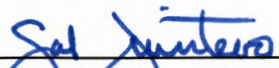

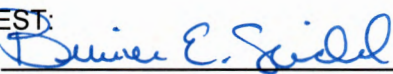
