

### SUMMARY

NOTICE is hereby given that at its regularly scheduled meeting on September 9, 2025, the Fresno County Board of Supervisors adopted Ordinance No. T-103-386, an Ordinance of the County of Fresno, State of California.

### SUMMARY OF ORDINANCE

To amend the County's Zoning Ordinance by modifying the text of the Fresno County Zoning Ordinance to amend Article 4, Chapter 834.4.270(B)(1), by incorporating Personal/Recreational vehicle storage into the AL (Limited Agriculture) Zone District for properties located within one-half mile of the adopted sphere of influence of the City of Fresno, contingent upon obtaining a Conditional Use Permit.

In accordance with Government Code Sections 25123, 25131, and 65854-65857, this Ordinance, identified as Ordinance No. T-103-386 shall take effect thirty days after its passage.
