WHEREAS, the County of Fresno, Sheriff-Coroner-Public Administrator's Office has costs of \$13,858,957; and

WHEREAS, the Sheriff-Coroner-Public Administrator's Office requires an additional \$13,858,957 in appropriations to pay for those costs; and

WHEREAS, the funds needed to offset those costs will be funded by a decrease in the 2230 Fund Balance – Unassigned Fund Balance in the General Fund ; and

WHEREAS, said monies are not included in the FY 2024-25 adopted appropriations of the Sheriff-Coroner-Public Administrator ORG 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Sheriff-Coroner-Public Administrator ORG 31111500 as follows:
