IN THE AMOUNT OF \$680,105)

WHEREAS, on November 18, 2025, the Fresno County Administrative Office created the Office of Housing and Homelessness Division to centralize the department of Housing and Urban Development, Department of Social Services, and County Administrative Office homelessness response roles and programs. This action required the creation of a Collaborative Applicant HUD Special Revenue Fund Org 0128; and

WHEREAS, the Collaborative Applicant HUD Org 0128 requires the establishment of appropriations and estimated revenues in the amount of \$680,105 to receive associated federal revenues and transfer funds to the Office of Housing and Homelessness Org 5428 to pay associated expenditures; and

WHEREAS, said monies are not included in the Collaborative Applicant HUD Org 0128 FY 2025-26 adopted appropriations and revenues; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to establish the appropriations and estimated revenues in the FY 2025-26 Collaborative Applicant HUD Org 0128 as follows:

- SUBCLASS 17023
- ORG 0128 Collaborative Applicant HUD
