WHEREAS, the Sheriff-Coroner Organization (Org) 3111 will receive \$284,487 as  
Operating Transfer In from the Sheriff-Coroner Special Revenue Fund 0095, Sheriff-CA St Corr  
Train Org 1452, Debtor Assessment Fee Org 1454, Sheriff Automated GC 26731 Org 1455,  
Federal Asset Forfeiture Org 1459 and Indigent Burial Trust Fund Org 1465; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and  
estimated revenues of the Sheriff Org 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of  
these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector  
is authorized to increase the appropriations in the FY 2017-18 Sheriff Organization 3111 as  
follows:

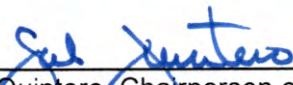
