

1 FIRST AMENDMENT TO AGREEMENT

2 THIS FIRST AMENDMENT TO AGREEMENT 15-551 is made this 18th day of
3 October, 2016, by the COUNTY OF FRESNO, a political subdivision of the State of
4 California (COUNTY), and Doug Koerper, sole proprietor of Doug Koerper Construction,
5 P.O Box 484, Shaver Lake, CA 93664 (CONTRACTOR).

6 WHEREAS, the parties entered into an Agreement on October 27, 2015,
7 identified as COUNTY Agreement 15-551, for CONTRACTOR to provide snow removal
8 services on roads in County Service Area No. 35, zones AT, AS, Solitude Lane to
9 Shaver Lake Wastewater Treatment Plant, and Bretz Road from State Highway 168 to
10 Slick Rock Lane (Agreement); and

11 WHEREAS, the parties desire to amend the Agreement as stated below.

12 THE PARTIES THEREFORE AGREE AS FOLLOWS:

13 1. Section 7 of the Agreement is amended as follows. Beginning on page 11,
14 line 20, the following text is deleted:

15 "This agreement is effective when signed through October 31, 2018, provided
16 however that this agreement may be extended for no more than two one-year
17 periods after October 31, 2018, by the COUNTY Representative. To exercise
18 each one-year extension, the COUNTY Representative will notify the
19 CONTRACTOR of the extension by written letter before June 30, 2018, for the
20 first extension and before June 30, 2019, for the second extension."

21 and replaced with the following:

22 "This agreement is effective when signed through the date when the First
23 Amendment is signed."

24 2. COUNTY and CONTRACTOR agree that this First Amendment is
25 sufficient to amend the Agreement, and that, upon execution of this First Amendment,
26 the Agreement, and this First Amendment together shall be considered the Agreement.

27 3. COUNTY and CONTRACTOR agree that as of the date when this First
28 Amendment is signed, COUNTY has paid all compensation to CONTRACTOR as

3. The Agreement, as hereby amended, is ratified and continued. All provisions, terms, covenants, conditions, and promises contained in the Agreement and not amended by this First Amendment remain in full force and effect.

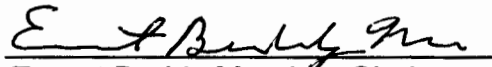
