WHEREAS, the State called for a Statewide Special Election to be held on November 4, 2025; and

WHEREAS, additional funding is needed to pay Extra Help and Overtime salaries and benefits, ballot printing, and expenditures resulting from this election; and

WHEREAS, the State has committed to reimburse counties for the additional costs incurred to conduct this election during FY 2025-26; and

WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations and estimated revenues of the County Clerk-Elections Org 28500600; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2025-26 County Clerk-Elections Org 28500600 as follows:


