5 AN ORDINANCE AMENDING CHAPTER 2.72, BY AMENDING SECTIONS 2.72.010,
6 2.72.020, 2.72.030, 2.72.040, 2.72.050, 2.72.060 AND 2.72.070 TO THE ORDINANCE CODE
7 OF THE COUNTY OF FRESNO PERTAINING TO ESTABLISHMENT OF SUPERVISORIAL
8 DISTRICTS BY ORDINANCE OR RESOLUTION.

9 The Board of Supervisors of the County of Fresno ordains as follows:

10 **Section 1.** That Chapter 2.72 of the Ordinance Code of the County of Fresno is hereby
11 amended to read as follows:

12 **“2.72.010 Establishment.**

13 Pursuant to Chapter 6 of Division 21 of the California Elections Code and the Charter of
14 the County of Fresno, the boundaries and numerical designations of the supervisorial districts
15 for the County of Fresno are established as set forth in this chapter by ordinance or by
16 resolution duly adopted by the Fresno County Board of Supervisors pursuant to California State
17 law.

3 **2.72.070 Interpretation of boundary descriptions.**

4 All references to streets, ways, avenues, roads, state routes or alignments and
5 projections thereof, railroads, and watercourses, contained in the foregoing boundary
6 descriptions or in the boundary descriptions set forth in any resolution adopted pursuant to this
7 Chapter and California State law refer to the centerlines thereof.”

8 **Section 2:** This ordinance shall take effect thirty (30) days after final passage of this ordinance
9 with the exception of the amendments to Sections 2.27.020, 2.27.030, 2.27.040, 2.27.050 and
10 2.72.060 which shall take effect on December 14, 2021, following adoption by the Fresno
11 County Board of Supervisors of new supervisorial district boundaries by ordinance or resolution.




