AMENDMENT NO. 5 TO SERVICE AGREEMENT

This Amendment No. 5 to Service Agreement ("Amendment No. 5") is dated

December 17, 2024 and is by and between the County of Fresno, a political subdivision of the State of California ("County"), and each Provider listed in Revised Exhibit A-4, "List of Providers" (collectively referred to as "Provider"). Reference in this Agreement to "party" or "parties" shall be understood to refer to County and each provider unless otherwise specified.

Recitals

- A. On June 23, 2020, the County and Provider entered into Individual/Group Provider Master Agreement, which is County Agreement No. 20-236, for specialty mental health services to County's Medi-Cal beneficiaries; and
- B. On June 30, 2023, the County and Provider amended the above service Agreement, which is Agreement No. 23-271 to add additional Providers to the Agreement and incorporate a new billing structure due to the implementation of the California Advancing and Innovating Medi-Cal (CalAIM) initiative by the Department of Health Care Services; and
- C. On January 9, 2024 the County and Provider amended the above service Agreement, which is Agreement No. 24-021 to add additional providers to the Agreement; and
- D. On May 21, 2024 the County and Provider amended the above service Agreement, which is Agreement No. 24-217 to add additional providers to the Agreement, remove providers from the Agreement, and increase maximum compensation to the Agreement; and
- E. On November 5, 2024 the County and Provider amended the above service Agreement which is Agreement No. 24-574 to add additional providers to the Agreement; and
- F. The County now desires to retroactively increase the maximum compensation for this Agreement for fiscal years 2023-2024 and 2024-2025 due to an unexpected increase in reimbursable services; and upon execution of this Amendment No. 5, update individual provider Karina Cisneros to Karina Baca due to her legal name changing.

The parties therefore agree as follows:

1. Section 4 of the Agreement located at page 6 line 23 through page 7 line 3 is deleted and replaced with the following:

"For the period effective from July 1, 2023 through June 30, 2024, the maximum compensation amount under this Agreement shall not exceed Seven Million Five Hundred Thousand and No/100 Dollars (\$7,500,000.00) for all Providers combined.

For the period effective from July 1, 2024 through June 30, 2025, the maximum compensation amount under this Agreement shall not exceed Eight Million and No/100 Dollars (\$8,000,000.00) for all Providers combined.

For the entire term of this Agreement, the total maximum compensation amount under this Agreement shall not exceed Twenty Eight Million Seven Hundred Thirty Nine Thousand Eight Hundred Thirty Eight and No/100 Dollars (\$28,739,838.00) for all Providers combined."

- 2. This Amendment No. 5 is effective retroactive to July 1, 2023, unless otherwise indicated in this Amendment No. 5.
- 3. When both parties have signed this Amendment No. 5, the Agreement, Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4, and this Amendment No. 5 together constitute the Agreement.
 - 4. The Contractor represents and warrants to the County that:
 - a. The Contractor is duly authorized and empowered to sign and perform its obligations under this Amendment.
 - b. The individual signing this Amendment on behalf of the Contractor is duly authorized to do so and his or her signature on this Amendment legally binds the Contractor to the terms of this Amendment.
- 5. The parties agree that this Amendment may be executed by electronic signature as provided in this section.
 - a. An "electronic signature" means any symbol or process intended by an individual signing this Amendment to represent their signature, including but not limited to (1) a digital signature; (2) a faxed version of an original handwritten signature; or (3) an

- electronically scanned and transmitted (for example by PDF document) version of an original handwritten signature.
- b. Each electronic signature affixed or attached to this Amendment (1) is deemed equivalent to a valid original handwritten signature of the person signing this Amendment for all purposes, including but not limited to evidentiary proof in any administrative or judicial proceeding, and (2) has the same force and effect as the valid original handwritten signature of that person.
- c. The provisions of this section satisfy the requirements of Civil Code section 1633.5,
 subdivision (b), in the Uniform Electronic Transaction Act (Civil Code, Division 3, Part
 2, Title 2.5, beginning with section 1633.1).
- d. Each party using a digital signature represents that it has undertaken and satisfied the requirements of Government Code section 16.5, subdivision (a), paragraphs (1) through (5), and agrees that each other party may rely upon that representation.
- e. This Amendment is not conditioned upon the parties conducting the transactions under it by electronic means and either party may sign this Amendment with an original handwritten signature.
- 6. This Amendment may be signed in counterparts, each of which is an original, and all of which together constitute this Amendment.
- 7. The Agreement as previously amended and as amended by this Amendment No. 5 is ratified and continued. All provisions of the Agreement as previously amended and not amended by this Amendment No. 5 remain in full force and effect.
