WHEREAS, the National Association of Government Defined Contribution Administrators (NAGDCA) created the Art Caple President's Award, which honors excellence in public sector defined contribution plans, and celebrates visionary leadership, innovation that enhances participants' financial well-being, and strategies that help participants save more for retirement; and

WHEREAS, the County of Fresno, in partnership with Nationwide Retirement Solutions, submitted an entry for the Art Caple President's Award based on the County's efforts to increase participation in the 457(b) Deferred Compensation Plan, including the annual Save Today! and Active Choice Enrollment campaigns, implementing a New Hire Active Choice Enrollment Program, and the Board of Supervisors' adoption of Employer Matching Contribution; and



WHEREAS, on September 29, 2025, during the 2025 National Association of Government Defined Contribution Administrators Annual Conference, the NAGDCA presented the 2025 Art Caple President's Award to the Department of Human Resources formally recognizing the County's achievement and remarkable success in increasing participation and fostering a culture of savings.
