RESOLUTION

WHEREAS, the Internal Services Department, Facility Services, Org 8935, requires an increase in appropriations and estimated revenues in the amount of \$100,000 to allow for the payment of architectural consulting services necessary to meet departmental demands and use; and

WHEREAS, said additional costs will be financed by revenue from user departments benefiting from said services in the amount of \$100,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2020-21 Facility Services, Org 8935; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors.

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2020-21 Facility Services, Org 8935 as follows:
