AMOUNT OF \$723,897)

WHEREAS, the Welfare Advance Fund Organization 1120 requires additional appropriations to fund an Operating Transfers Out to the Department of Social Services Organization 5610 in the amount of \$723,897 to meet expenditures associated with the additional staffing; and

WHEREAS, the Welfare Advance Fund Organization 1120 will receive funding from the State and Federal government in the amount \$723,897 in FY 2016-17; and

WHEREAS, \$723,897 is not included in the FY 2016-17 adopted appropriations and estimated revenues of the Welfare Advance Fund Organization 1120 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Welfare Advance Fund Organization 1120 as follows:

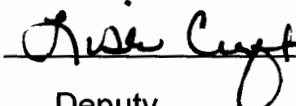
