NOTICE is hereby given that at its regularly scheduled meeting on November 7, 2023, the Fresno County Board of Supervisors adopted Ordinance No. 23-012, an Ordinance of the County of Fresno, State of California.

SUMMARY OF ORDINANCE

This Ordinance calls for a special election to be held on March 5, 2024, for the purpose of voting upon a measure to amend Section 15 of the Charter of the County of Fresno ("County") to establish the election dates for the Sheriff, District Attorney, and all other elective County officers except members of the Board of Supervisors, to be held in gubernatorial, non-presidential election years and set the term of office for the current Sheriff and District Attorney to four (4) years. The Ordinance also resolves and orders the consolidation of this election with the Statewide Primary Election to be held on the same day, March 5, 2024.
