WHEREAS, the Office of the District Attorney-Grants Organization (Org) 2862 has the opportunity to purchase one (1) vehicle for use during investigations related to the Disability and Healthcare (DHC) Fraud program in the current year; and

WHEREAS, the District Attorney-Grants Org 2862 has funds available through the DHC Insurance Fraud Program to support criminal investigations involving disability and healthcare in the amount of \$36,000; and

WHEREAS, the Fleet Services-Equipment Org 8911 will receive \$36,000 as an Operating Transfer In from the District Attorney-Grants Org 2862 to purchase the vehicle; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2016-17 Fleet Services-Equipment Org 8911 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Fleet Services-Equipment Org 8911 as follows:

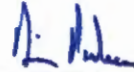
