WHEREAS, the County of Fresno, Information Technology Services, Organization (Org) 8905, requires an increase in appropriations in the amount of \$200,000 to allow for the payment of audiovisual services and equipment necessary to meet departmental demands and use; and

WHEREAS, said additional costs will be financed by revenue from user County Departments benefiting from said services in the amount of \$200,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2018-19 Information Technology Services, Org 8905 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2018-19 Information Technology Services, Org 8905 as follows:

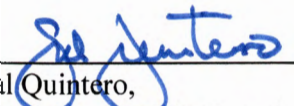

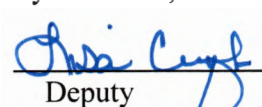
