WHEREAS, the Department of Social Services (DSS), Organization (Org) 56107001 has the opportunity to purchase two vans to be used for outreach to clients in rural and disaster areas that do not have access to DSS offices in the current year; and

WHEREAS, DSS Org 56107001 has funds available through State and Federal Social Services funds and available Net County Cost for the purchase of two vans in the amount of \$400,000; and

WHEREAS, the Fleet Services-Equipment Org 8911 will receive \$400,000 as an Operating Transfer In from DSS Org 56107001 to purchase two vans; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2021-22 ISD - Fleet Services Equipment, Org 8911 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 ISD - Fleet Services Equipment Org 8911 as follows:


